

#### SURVEY NARRATIVE

ROOSEVELT AVE.

THIS REPLAT HAS BEEN PREPARED AT THE REQUEST OF WHITLOCK INVESTMENTS, LLC. THE PURPOSE IS TO RECONFIGURE LOTS 1-4 OF THE TOWN OF STANFIELD INTO 2 LOTS OF EQUAL AREA, AS SHOWN. MONUMENTS FOUND ALONG THE SOUTH MARGIN LINE OF BLOCK 6. MONUMENTS "C", "H" & "J" WERE USED TO DETERMINE THE WEST LINE OF BLOCK 6. SEE MONUMENT TABLE DESCRIPTIONS FOR ADDITIONAL INFORMATION ON CONTROLLING MONUMENTATION. RESULTING BLOCK 6 WAS THEN DIVIDED USING TWO TOPCON HIPER LITE+ GNSS UNITS OPERATED USING RTK METHODS. THE BASIS OF BEARING IS THE WEST LINE OF PARCEL 3 OF PARTITION PLAT 2018-07 AS DETERMINED BY MEASURE BETWEEN FOUND RECORD CORNERS AS SHOWN DISTANCES ARE GROUND, INTERNATIONAL FEET.


