NARRATIVE

THIS SURVEY WAS MADE AT THE REQUEST OF WAYNE SIMPSON TO ADD A PORTION OF PARCEL 2 OF PARTITION PLAT 2017-17, TO LOT 18 OF ROYAL RIDGE SUBDIVISION PHASE 1 AS SHOWN. THE OVERALL BOUNDARIES OF BOTH WERE PREVIOUSLY SURVEYED. THE REASON THIS IS BEING DONE IS SO A HOUSE CAN BE CONSTRUCTED. THE SLOPE OF THE GROUND IS VERY STEEP AND A FILL AREA IS NEEDED FOR CONSTRUCTION BECAUSE OF THE SLOPE.

THE SURVEY WAS MADE BY A 2 PERSON CREW USING A LECIA GS14 GPS RECEIVER OPERATED OVER THE OREGON REALTIME GNSS NETWORK.
