

## SURVEYORS CERTIFICATE & NARRATIVE

I WILLIAM R. WELLS, A PROFESSIONAL LAND SURVEYOR IN THE STATE OF OREGON, DO HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH LEGAL MONUMENTS, IN ACCORDANCE WITH O.R.S. CHAPTER 92, AS REVISED, OR AS APPROVED BY THE UMATILLA COUNTY SURVEYOR. THE LANDS SHOWN IN THE ACCOMPANYING PLAT OF "KISHPAUGH REPLAT".

THE CONTROL AND MONUMENTATION SURVEY WAS MADE WITH A LEICA GEODETIC GPS RECEIVER CONNECTED TO THE OREGON REAL TIME NETWORK AND WITH A TRIMBLE S-6 THREE SECOND ROBOT TOTAL STATION. MEASUREMENTS TO CONTROLING MONUMENTS AND MONUMENTS SET WERE VERIFIED BY REDUNDANT MEASUREMENTS.

PER ORS CHAPTER 92.065 AND 92.070, I CERTIFY THAT THE REMAINING MONUMENTS NECESSARY TO DEFINE THE NEW LOTS WILL BE SET, IN ACCORDANCE WITH ORS CHAPTER 92.060, BY DECEMBER 31, 2022.

### NARRATIVE:

THE REPLAT IS OF LOTS 1 AND 2 OF MRS. LADOW'S ADDITION, RECORDED OCTOBER 16, 1877 IN DEED BOOK C, PAGE 627. THE ORIGINAL PLAT SHOWED THE NORTHERLY LINES OF THE TWO LOTS AS ALONG THE EDGE OF THE UMATILLA RIVER, WITH THE WESTERLY LINE OF LOT 1 ALONG THE EASTERLY LINE OF VINCENT STREET, (NOW S.E. 5TH STREET) AND THE SOUTHERLY LINE OF LOTS 1 AND 2 ALONG THE NORTHERLY LINE OF LEWIS STREET, (NOW S.E. BYERS AVENUE). THE RECORD DISTANCE OF 50 FEET, MEASURED ALONG THE NORTH LINE OF LEWIS STREET, WAS HELD FOR THE WIDTH OF LOTS 1 AND 2 IN THIS REPLAT SURVEY. VINCENT STREET, WITH A WIDTH OF 60 FEET, WAS APPARENTLY PLATTED AS PART OF THE TOWN OF PENDLETON PLAT RECORDED IN DEED BOOK B, PAGE 2, IN 1868. THE TOWN OF PENDLETON PLAT DOES NOT SHOW THE EAST LINE OF VINCENT STREET. MRS. LADOW'S DEED IN SEPTEMBER 1877, CONVEYED TO HER LANDS SOUTH OF THE UMATILLA RIVER AND EAST OF THE EAST SIDE OF VINCENT STREET. THE PART OF LEWIS STREET EAST OF VINCENT STREET WAS PLATTED AS PART OF MRS. LADOW'S ADDITION. AS NOTED ON THE SURVEY NO. Q-89-AX, (1961), SURVEY NO. A-57-AX, (1966) AND MY PARTITION PLAT NO. 2003-23, THERE HAS BEEN SOME CONFUSION ON THE WIDTH OF LEWIS STREET AND THE LOCATION OF THE NORTH RIGHT-OF-WAY LINE. UPON FURTHER RESEARCH, I DETERMINE THE WIDTH OF LEWIS STREET IS 50 FEET. ALTHOUGH UNDIMENSIONED, IT CLEARLY SHOWS AS THE SAME WIDTH AS LOT 2, BLOCK 10 OF THE ORIGINAL TOWN OF PENDLETON, AS 50 FEET CRIGER'S SURVEYS IN THE 1940'S AND 1950'S SHOW THE WIDTH AT 50 FEET. I ALSO NOTE THERE IS A BEARING DISCREPANCY ON MRS. LADOW'S PLAT TO THE POINT OF COMMENCEMENT. THE RECORD CALL OF N 24' E SHOULD BE N 66' E. THERE ARE ALSO SEVERAL INCORRECT CALLS IN THE DEED FROM ANNA ROESCH TO FREIDA STEIWER IN THE 1922 DEED RECORDED AT BOOK 116, PAGE 582, DEED RECORDS.

DIMENSIONS TO THE SOUTH EDGE OF THE UMATILLA RIVER ON THE ORIGINAL PLAT OF MRS. LADOW'S ADDITION WERE 260 FEET ALONG THE WEST LINE OF LOT 1 AND 240 FEET ALONG THE EAST LINE OF LOT 2. TODAY'S MEASUREMENTS ARE CONSIDERABILY LONGER DUE TO MOVEMENT OF THE RIVER CHANNEL AND "CHANNELIZATION" OF THE RIVER BY LEVEE CONSTRUCTION. IT APPEARS, BASED ON THE 1881 MAP OF THE TOWN OF PENDLETON, PREPARED BY H.D. CHAPMAN, CIVIL ENGINEER, THAT THERE WERE TWO CHANNELS FOR THE RIVER AND MRS. LADOW'S OWNERSHIP WAS SOUTH OF THE SOUTH EDGE OF THE SOUTHERLY CHANNEL, PICNIC ISLAND SEPARATED THE TWO CHANNELS ACCORDING TO THE CHAPMAN MAP. THE CHAPMAN MAP WAS PREPARED BY ORDER OF THE COMMON COUNCIL OF THE TOWN OF PENDLETON, AND IS RECORDED IN BOOK 1, OF DEEDS AT PAGE 682.

I HAVE CALCULATED TWO AREAS FOR NEW LOT 4. THE SOUTHERLY AREA OF 6711 SQUARE FEET IS COMPUTED TO THE SOUTHERLY LINE OF THE 1958 COE LEVEE RIGHT-OF-WAY. I NOTE THAT ENCUMBRANCES FOR THE PLATTED PROPERTY CONTAIN NO REFERENCE TO THE COE 1958 LEVEE RIGHT-OF-WAY. THERE IS A LEVEE EASEMENT DEED ENCUMBERING THE PLATTED PROPERTY, RECORDED AT BOOK 120, PAGE 378, DEED RECORDS. NO LOCATION INFORMATION IS CONTAINED IN THE EASEMENT DEED. THE NORTHERLY AREA OF LOT 4, APPROXIMATELY 8590 SQUARE FEET, IS WITHIN THE NORTHERLY PROJECTED EASTERLY AND WESTERLY LINES OF NEW LOT 4, FROM THE SOUTHERLY LINE OF THE 1958 COE LEVEE RIGHT-OF-WAY TO THE APPROXIMATE EDGE OF WATER SHOWN ON JUNE, 2019 GOOGLE IMAGE.

I COMPUTED COE LEVEE BASE LINE BETWEEN PREVIOUSLY TIED 1958 LEVEE BASE LINE MONUMENT UM-18 AND ACCESSORIES FOR UM-20 FURNISHED BY THE CITY OF PENDLETON. SEE MY SURVEY NO. 94-002-B AND 00-22-C. THE CHISELED CROSSES IN THE CONCRETE LEVEE RETAINING WALL REPORTED AT LEVEE STATION L 58+18.2 AND L 61+81.3 REPORTED ON SURVEY NO. Q-89-AX WERE SEARCHED BUT NOT RECOVERED. EROSION ON THE TOP OF THE LEVEE WALL HAS OBILITERATED DEFINATE IDENTIFICATION OF THE CHISELED CROSSES. MY COMPUTED LEVEE BASE LINE COMPUTATIONS AGREE WITH THOSE OF SURVEY NO. Q-89-AX WITHIN 0.01 TO 0.03 FOOT.

AS DESCRIBED BY OWNERSHIP AND ENCUMBRANCE REPORT WITH EASEMENTS ORDER NO. 102520, PREPARED BY PIONEER TITLE COMPANY, 109 SW COURT AVENUE, PENDLETON, OREGON, DATED MAY 12, 2021.

THE SOUTH 174.9 FEET OF LOTS 1 AND 2, BLOCK 1, LADOW'S ADDITION TO THE TOWN, NOW CITY OF PENDLETON, UMATILLA COUNTY, OREGON.

A PARCEL OF LAND 50 FEET BY 100 FEET LOCATED IN LOTS 1 AND 2, BLOCK 1, LADOW'S ADDITION TO THE TOWN, NOW CITY OF PENDLETON DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON THE WEST LINE OF SAID LOT 1, 174.90 FEET DISTANT FROM THE SOUTHWEST CORNER OF SAID LOT 1, \*\*WHICH SOUTHWEST CORNER IS NORTH 66'00' WEST. A DISTANCE OF 44.50 FEET FROM THE INITIAL OR STARTING POINT OF SAID LADOW'S ADDITION\*\* THENCE FROM SAID POINT OF BEGINNING ON THE WEST SIDE OF SAID LOT 1 AND AT RIGHT ANGLES ACROSS SAID LOTS 1 AND 2, A DISTANCE OF 100 FEET, MORE OR LESS, TO THE LOT LINE BETWEEN LOTS 2 AND 3; THENCE NORTHERLY A DISTANCE OF 50 FEET ALONG THE LOT LINE BETWEEN LOTS 2 AND 3; THENCE WESTERLY A DISTANCE OF 100 FEET, MORE OR LESS, AT RIGHT ANGLES TO SAID LOTS 1 AND 2, TO A POINT ON THE WEST SIDE OF SAID LOT 1, SAID POINT BEING 50 FEET DISTANCE IN A NORTHERLY DIRECTION FROM THE POINT OF BEGINNING; THENCE SOUTHERLY A DISTANCE OF 50 FEET ALONG THE WEST LINE OF SAID LOT 1, THE WEST LINE OF SAID LOT 1 ALSO BEING THE EAST SIDE OF VINCENT STREET, AS LAID OUT IN THE CITY OF PENDLETON, TO THE POINT OF BEGINNING.

SURVEYOR'S NOTE: THE UNDERLINED WORDS BETWEEN THE DOUBLE ASTERISKS IN THE ABOVE TRACT II DESCRIPTION ARE SUPERFLUOUS AND ARE IN FACT, IN ERROR, AND ARE OMITTED IN CONSTRUING THE TRACT II DESCRIPTION.

ALL THAT PORTION ON LOTS 1 AND 2, BLOCK 1, LADOW'S ADDITION TO THE TOWN, NOW CITY OF PENDLETON, UMATILLA COUNTY, OREGON, LYING NORTH OF THE NORTH LINE OF THAT TRACT OF LAND CONVEYED TO FREIDA STEIWER, FORMERLY FREIDA ROESCH, BY DEED RECORDED IN BOOK 116, PAGE 582, DEED RECORDS, UMATILLA COUNTY, OREGON. SURVEYOR'S NOTE: TRACT CONVEYED IN BOOK 116, PAGE 582 IS TRACT II ABOVE.
