

NARRATIVE OF SURVEY

This plat was prepared at the request of Mr. Darrell Simpson. The purpose of the plat is to Replat lots 2, 3, 14 and 15 of Block 246 as shown hereon to consolidate these four lots into one lot.

The block and lot lines were located and monumented by myself in 2018 in County Survey 18-022-B. I find the monuments from that survey in good condition and have held them as marking the true location of the boundary of this replat.

Confirmation of monument location and of my prior measurements was done with a Trimble R8S RTK GPS base / rover pair.

SURVEYOR'S CERTIFICATE

I, Stephen K. Haddock, a Registered Professional Surveyor in the State of Oregon, do hereby certify that I have correctly surveyed and marked with legal monuments Lot 1 of this Replat as shown hereon. I do also state that the initial point is is monumented with a 5/8"x24" Iron Rebar with an orange plastic cap stamped WTS and 56295LS set by me in Umatilla County survey 18-022-8.

NEW EASEMENT DESCRIPTIONS

The two easements described below are for uses that have been in place beginning some time around 1994. The uses are for "A" delivery of electric power and "B" ingress and egress to blocks 244, 245, 246, and 247 of the Reservation Addition to the City of Pendleton. All maintenance and restoration of the facilities in these easements shall be the responsibility of those parties to whom the structures appurtain.

An easement for the existing PP&L overhead power line. The easement shall be 10 feet wide lying 5 feet on each side of the power line in the location where shown on sheet 1 of this plat. This is a public electric utility easement.

An easement for the existing driveways. The easement from Microfilm Reel 560, Page 509 states that that easement is to run "over an existing road". That description is not definite and, where there are two prior existing roads, the easement created hereby will clearly define that part of the easement area lying across lot 14. The remaining easement is unaffected. This easement will be over that part of original Lot 14, Block 246 lying on said Lot 14 southerly of the line running from the Northwest corner of said Lot 14 to the Southeast corner thereof. This is a private access easement.
