SURVEYOR'S CERTIFICATE

I, ROBERT D. ENGLISH, OREGON PROFESSIONAL LAND SURVEYOR NUMBER 43406LS, BEING DULY SWORN, DEPOSE AND SAY THAT I HAVE SURVEYED AND MARKED WITH LEGAL MONUMENTS THE LANDS SHOWN ON THIS REPLAT, AS SHOWN HEREIN. SAID REPLAT IS SITUATED IN THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 10, AND THE NORTHWEST 1/4 OF THE NORTHEAST 1/4 OF SECTION 15, TOWNSHIP 2 NORTH, RANGE 32, EAST OF THE WILLAMETTE MERIDIAN. CITY OF PENDLETON, UMATILLA COUNTY, OREGON. THE PURPOSE OF THIS REPLAT IS TO ERASE THE LOT LINES INSIDE OF LOT 7 OF BLOCK I OF WEST VIEW ADDITION, AND THE NORTH LINE OF LOT I, BLOCK 3 OF SUNSET WEST ADDITION TO THE CITY OF PENDLETON.

I FURTHER CERTIFY AND SAY THAT I MADE THIS SURVEY AND PLAT BY ORDER OF AND UNDER THE DIRECTION OF THE OWNERS THEREOF, AND THAT ALL BOUNDARY CORNERS ARE MARKED WITH MONUMENTS AS INDICATED ON THE AMENDED MAP IN ACCORDANCE WITH THE PROVISIONS OF O.R.S. 92.050 AND 92.060.

SURVEYOR'S NARRATIVE:

THIS SURVEY WAS PERFORMED AT THE REQUEST OF STEVE CALDWELL, OWNER, TO PERFORM A REPLAT OF LOT 7 OF BLOCK I OF WEST VIEW ADDITION, AND LOT I OF BLOCK 3 OF SUNSET WEST ADDITION WHICH IS LOCATED IN THE SWI/4 OF THE SEI/4 OF SECTION 10. AND THE NEI/4 & NWI/4 OF SECTION 15. TOWNSHIP 2 NORTH. RANGE 32 EAST OF THE WILLAMETTE MERIDIAN, CITY OF PENDLETON, UMATILLA COUNTY, OREGON.

I WAS ABLE TO LOCATE SEVERAL OF THE PROPERTY CORNERS ON THIS PROPERTY, ALTHOUGH MANY HAVE BEEN DISTURBED OVER THE LAST SEVERAL YEARS.

BASIS OF BEARING IS THE SOUTH LINE OF WESTVIEW ADDITION BETWEEN THE SECTION CORNER AND THE BRASS DISC AT THE INITIAL POINT WHICH IS UNDISTURBED. I HOLD PLAT BEARINGS AND DISTANCES BETWEEN THESE TWO POINTS FOR THE BASIS OF THIS SURVEY.

THIS SURVEY WAS PERFORMED USING A CARLSON BRX7 RTK GPS SYSTEM. STANDARD ERROR FOR THE RTK SYSTEM IS 8.0MM + I PPM X BASELINE MEASURED, IN MILLIMETERS, AND A TOPCON PS-103A ROBOTIC TOTAL STATION.

I USE NAD83 ORNSPC COORDINATES FOR THIS SURVEY. I FIND NOTHING OUT OF THE ORDINARY ON THIS SURVEY.
