

NARRATIVE OF SURVEY

This plat was prepared at the request of Mr. Ronald Piatt. The purpose of the survey is to replat the lands described in the legal description and combine them into one lot.

The property included in this replat was conveyed to the Ronald and Mary Jo Piatt Trust by the deed documents recorded as instrument numbers 2018-6760233, 2023-08162, and 2024-08378, Umatilla County Records. With the exception of that line lying 40 feet north of the southerly line of Block 9, all monuments on the replat boundary are at corners of the Rancho Vista Addition. Those monuments shown as "found" on this replat were on average 4 to 6 inches below the surface of the ground. The majority of those found along the roadways were bent to various extents. Measurements were made to where the monuments turned to the vertical. The northeast corner of Lot 2 was not remonumented because it marks a line being removed by this replat. The deeded line identifying the southerly 40 feet of Lot 9 was monumented at the deed distance of 40 feet north of the original line common to lots 8 and 9 during the boundary adjustment survey recorded as Umatilla County Survey 24-27-B.

This survey was performed with a Trimble R8S RTK GPS base/rover pair.

SURVEYOR'S CERTIFICATE

I, Stephen K. Haddock, a Registered Professional Surveyor in the State of Oregon, do hereby certify that I have correctly surveyed and marked with legal monuments the lands described hereon. I do also state that the initial point of this replat is the southeast corner of Lot 2. Block 4 of the Rancho Vista Addition to Umatilla County and is monumented with the original 1/2" iron rebar as shown hereon.

LEGAL DESCRIPTION

All of that portion of Block 4 of the Rancho Vista Addition to Umatilla County, Oregon recorded on May 11th, 1960 as Instrument No. 226398 in Book 8, Page 34 of the Record of Town Plats of said Umatilla County, said portion consisting of the following: Lot 2. Lot 8. The southerly 40 feet of Lot 9. and that portion of Lot 1 described as: Beginning at the corner common to Lots 1, 2, and 9 of said Block 4. thence along the line common to said Lots 1 and 2, N85°36'00"E a distance of 151.68 feet to the easterly corner common to said Lots 1 and 2. said point lying on the westerly line of Lakeside Road, thence along said westerly line 27.57 feet along the arc of a curve to the right having a radius of 330.00 feet, and a central angle of 4°47'12", the long chord of which bears NO2°00'30"W a distance of 27.56 feet to a 5/8" iron repar marking the end of said curve; thence S77°55'15"W a distance of 68.11 feet to a 5/8" iron rebar; thence S73°15'37"W a distance of 87.50 feet to the point of beginning.
