

1. MONUMENTS SET BY PERRY AT THE INTERSECTION OF THE CENTERLINES OF MAIN STREET WITH ALBA STREET AND WELL STREET WITH ALBA STREET ARE COVERED. NO ATTEMPT WAS MADE TO DESTROY STREET SURFACING TO OCCUPY THESE MONUMENTS.

2. NO EVIDENCE WAS FOUND OF THE PERRY MONUMENT AT THE INTERSECTION OF THE CENTERLINES OF ALBA STREET AND HILL STREET. THIS MONUMENT MAY ALSO BE COVERED, AS THE POSITION IS IN THE WEST EDGE OF THE STREET PAVEMENT.

3. BLOCKS 10 AND 11 ARE LOCATED AT RECORD POSITION FROM THE MONUMENT RECOVERED AT THE INTERSECTION OF THE CENTERLINES OF ALBA STREET AND DeSPAIN STREET, AS SHOWN ON THE PERRY PLAT OF SURVEY NO. 0-2-C.


