## Deed Description:

From Estate to Harold S. Jackson:

Beginning at the NW/cor. of Sec. 9, T. 4N., R. 34 EWM., run southerly on the W. Line of Sec. 9 - 1276.3 ft. to an iron pin; thence easterly and parallel with the EW centerline of the N/2 of Sec. 9 - 4627.3 ft. to a point; thence N. 11 degrees 18' W. 359.6 ft. to a point; thence N. 57 degrees 09 minutes W. 250.25 ft., to a point; thence N. 32 degrees 15' W 316.25 ft. to a point; thence N. 49 degrees 50' W. 480.0 ft. to a point; thence N. 40 degrees 50' W. 270.8 ft., to the N. line of sec. 9, (which is also the centerline of Co. Road No. 131); thence westerly on said N. line of Sec. 9, - 3584.6 ft. M/L to the point of beginning; except the North 20 of the above described tract which is used for road purposes; and also except a private road 16 ft. wide in the N/2 of the NW/4 of Sec. 9 - T 4N., R. 34 EWM - and as recorded in Umatilla County Deed Records, Book 37 P. 448.

The above description includes the N/2 of the NW/4 and a part of the NW<sup>1/4</sup> of the NE/4 (Bounded on the easterly side by the above described meander line); exclusive of the S 54 $\frac{1}{2}$  ft and the noted exceptions.
