

MILTON-FREEWATER MONUMENTATION

PURPOSE OF SURVEY

The purpose of this survey was to reference found monumentation for their recovery, on Oregon Department of Transportation's (ODOT) Milton-Freewater paving and North Lamb - Main Street reconstruction project; These monumentation's are located in Township 5 North, Range 35 East and Township 6 North, Range 35 East. Monumentation's in Milton-Freewater are located from 4th street and Main street to 8th street and Lamb street. Monuments outside of Milton-Freewater City limits are on Old Milton-Freewater Highway 339 and Umapine highway 339.

PROCEDURES USED TO ESTABLISH MONUMENT REFERENCE CONTROL

Found monument's on Highway 339 and 332 were referenced by OTAK. OTAK referenced each monument with four 5/8" X 30" iron pins with yellow plastic caps labeled OTAK. ODOT cored the new asphalt to recover monuments. Many of them were railroad spikes and bolts set in the overlayed pavement; most of these points were disturbed by coring operation. ODOT replaced the disturbed monuments with a 3" brass disc labeled Oregon State Highway Division; DO NOT DISTURB and stamped with appropriate data. Each 3" disc was set in a minimum of 12" of concrete poured on solid base. Each monument was recovered and replaced by ODOT as per field notes; using a direct and reverse sighting from reference monuments.

The monuments set on ODOT's North Lamb to Main Street construction project were set as per ODOT field notes using the same Standards as above on each monuments. The monuments on this project were tied prior to construction as per ODOT field notes. The monuments consist of three center line PI monuments located at 4th and Main, 8th and Main, and 8th and Lamb street; and one 1/16 corner at 8th and North Main.

MONUMENTS RESET

Monuments's that were reset by ODOT from OTAK references are:

Point number 10 is a 1/2 X 16 inch iron pin driven to bearing 1/2 inch below surface.

The monument set on 8th street and North Main street is a 1/16 corner, set from ODOT ties. Center line PI. monuments set are stations 212+95.99, 227+15.27, and 239+87.14; set from ODOT ties.

MONUMENTS RECOVERED


Monuments that were recovered undisturbed by ODOT from OTAK references are number 4 1/4 corner and number 18 1/16 corner.
