NARRATIVE OF SURVEY

THE PURPOSE OF THIS SURVEY WAS TO LOCATE 2 LOTS WITHIN ALLOTMENT UM 86 - UB, LOCATED IN THE SE 1/4 OF THE SW 1/4 OF SECTION 28, T2N, R33E, W. M.

THE SOUTH BOUNDARY OF THE SITE IS LOCATED ON THE NORTH RIGHT-OF-WAY LINE OF COUNTY ROAD NO. 936. AS SHOWN. THE RIGHT-OF-WAY OF COUNTY ROAD NO. 936. WAS DETERMINED USING THE SOUTH LINE OF SECTION 28 AS THE CENTERLINE OF THE ROAD RIGHT-OF-WAY. UTILITY EASEMENTS WERE PROVIDED, AS SHOWN, TO COVER EXISTING UTILITIES AND THE ACCESS ROAD SERVING THE EXISTING HOME ON LOT I. THE PRESENT SURVEY WAS MADE WITH A 2 PERSON CREW USING A MAC-II-H INFRA-RED DISTANCE METER AND T-IG THEODOLITE. BEARINGS FOR THIS SURVEY ARE BASED ON THE RECORD BEARINGS BETWEEN MONUMENTS ON THE WEST LINE OF SECTION AD 17 THE WEST LINE OF SECTION AS THE WEST LINE OF SECTION AS THE WEST LINE OF SECTION AS THE WEST LINE OF SECTION ON THE WEST LINE OF THE WEST L 30.
