All being in Township 1 North, Range 35, East of the Willamette Meridian, County of Umatilla, State of Oregon.

Gillanders to Pacific Northwest Pipeline Corporation, dated September 30, 1955, recorded December 14, 1955, Book 230, Page 417, Deed Records, and ratified March 12, 1957, Bood 240, Page 564, Deed Records. This easement is in the process of being smended as set forth in Exhibit A attached hereto, and shall be subsequently managed by the Corporation. secorded by the Grantor and;
