

NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO DEPICT THE ADJUSTED BOUNDARY LINE THAT BETWEEN THOSE PROPERTIES DESCRIBED AS TRACTS I AND III OF THE TRUSTEES DEED RECORDED AS DOC. NO. 2002-409520, DEED RECORDS OF UMATILLA COUNTY, OREGON.

THE FIELD WORK WAS PERFORMED BY JOHN D PUTNAM BETWEEN JUNE 18 AND AUGUST 16, 2002. MEASUREMENTS WERE COLLECTED USING TRIMBLE 4000SSI AND 4800 GPS RECEIVERS AND A LEICA ICRATIOS/RCSTIOU ROBOTIC TOTAL STATION.


BEARINGS ARE BASED ON THE OREGON COORDINATE SYSTEM OF 1983, NORTH ZONE. ALL DISTANCE SHOWN ON THIS SURVEY ARE REDUCED TO GROUND.

THE EXTERIOR OF SECTION 22, TOWNSHIP 4 NORTH, RANGE 28 EAST; THE SOUTH LINE OF THE SOUTHWEST ONE-QUARTER SECTION 21, TOWNSHIP 4 NORTH, RANGE 28 EAST AND THE RIGHT-OF-WAY OF THE UNION PACIFIC RAILROAD UMATILLA BRANCH WERE HELD PER THE ORION GPS, INC. RECORD OF SURVEY DATED NOVEMBER 12, 2002 AS RECORD OF SURVEY 02-293-B WITH THE UMATILLA COUNTY SURVEYOR'S OFFICE. THE NORTHERN LINE OF THE SOUTHWEST ONE-QUARTER SECTION 21, TOWNSHIP 4 NORTH, RANGE 28 EAST WAS ESTABLISHED BY HOLING THE LINE BETWEEN THE EAST AND WEST ONE-QUARTER CORNERS.

THE ADJUSTMENT LINE WAS ESTABLISHED PER DEED.

ALL FOUND MONUMENTS SHOWN ON THE FACE OF THIS SURVEY ARE HELD UNLESS A FALLING FROM THE TRUE LOCATION IS SHOWN.

NO MONUMENTS WERE SET AS A PART OF THIS SURVEY. IT IS ASSUMED THAT THE DEPICTED BOUNDARY LINE ADJUSTMENT WILL BE READJUSTED AS PART OF A FUTURE DEVELOPMENT OF THAT PROPERTY DESCRIBED AS TRACTS I, II III, IV, V AND VI OF THE TRUSTEES DEED RECORDED AS DOC. NO. 2002-409520, DEED RECORDS OF UMATILLA COUNTY, OREGON. IF NO DEVELOPMENT OCCURS AND/OR THE DEPICTED BOUNDARY LINE REMAINS UNCHANGED, HWC, INC WILL CAUSE MONUMENTS TO BE SET AT ALL ANGLE POINTS OF THIS BOUNDARY LINE ADJUSTMENT AND A NEW RECORD OF SURVEY WILL BE FILED WITH THE UMATILLA COUNTY SURVEYOR'S OFFICE.
