ON REEL 276 PAGE 745 (GREEN) THE RADIUS IS 220.62 FEET, WHEREAS ON REEL 430 PAGE 0338 (CARR) THE RADIUS IS 229.62 FEET. I HELD THE RADIUS AT 229.62 FEET, THE SAME AS ON SURVEY NUMBER 03-91-B.

I RECOVERED BRASS CAP MONUMENTS AT THE INTERSECTIONS OF MORROW STREET AND MAIN STREET AND ALSO AT THE INTERSECTIONS OF BOLLON STREET AND MAIN STREET. I HELD THESE TWO MONUMENTS AS THE CENTERLINE OF THEIR RESPECTIVE STREETS. THUS, MY BASIS OF BEARING IS THESE TWO FOUND MONUMENTS AND IS BASED ON SURVEY NUMBER 89-135-A (MUNRO FOR STEINER).

I ALSO RECOVERED THE MONUMENTS SET ON SURVEY NUMBER 03-91-B. I THEN TIED IN THE LOCATION OF THE RECENTLY ERECTED FENCE AND SET THREE MONUMENTS ALONG THIS FENCE. THE FIRST BEING AT THE INTERSECTION OF THE FENCE AND THE NORTHERELY RIGHT-OF-WAY LINE OF MAIN ST., THE SECOND BEING AT THE INTERSECTION OF THE FENCE AND THE NORTHERLY LOT LINE OF LOT 11, AND THE THIRD BEING AT THE INTERSECTION OF THE FENCE AND THE SOUTHERLY RIGHT-OF-WAY OF GEORGE ST.


