


AN AMENDED SURVEY FOR A BOUNDARY LINE ADJUSTMENT

NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF MARTHA SMITH TO ADJUST THE NORTH AND SOUTH BOUNDARIES OF HER PROPERTY TO THE EXISTING

I HAVE HELD THE WEST LINE OF THE CEMETERY PROPERTY AS BEING PARALLEL WITH THE WEST LINE OF THE SW 1/4 OF THE NW 1/4 OF SECTION 23 AS SHOWN ON SURVEYS H-8-A AND 01-133-B. THE NORTH AND SOUTH DEED LINES OF THE SMITH TRACT WERE HELD AS BEING PARALLEL WITH THE NORTH LINE OF SAID SW 1/4 NW 1/4 AND RECORD DEED DISTANCES SOUTH THEREFROM.

THIS SURVEY WAS PERFORMED BY RTK METHODS USING TOPCON DUAL FREQUENCY GPS RECEIVERS HAVING STANDARD ERRORS OF 1 CM +2PPM TIMES BASELINE LENGTH. ALL MONUMENTS SHOWN WERE VISITED AT THE TIME OF THIS SURVEY IN JULY AND AUGUST 2002.

NOTE

THE AMENDED SURVEY WAS PERPARED AND RECORDED TO CORRECT DISREPANCIES BETWEEN THE MAP AND THE LEGAL DESCRIPTION FOR PARCEL "B" AND PARCEL "C" AS SHOWN ON THE BOUNDARY LINE ADJUSTMENT UMATILLA COUNTY SURVEY RECORD NO. 02—217—B. THE OLD DIMENSION IS SHOWN WITH A DOUBLE LINE STRUCK THROUGH IT FOLLOWED BY THE CORRECT DIMENSION.
