BEGINNING AT A POINT 208 FEET EAST OF THE NORTHEAST CORNER OF THE WEST HALF OF THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 10, TOWNSHIP 4 NORTH, RANGE 28, E.W.M.; THENCE SOUTH 190.3 FEET; THENCE EAST 229 FEET; THENCE NORTH 190.3 FEET; THENCE WEST 229 FEET

EXCEPTING THE WEST 99 FEET THEREOF;





AND SW 11TH ST. MARKING THE SOUTH 1/16 CORNER OF SECTION 10. THUS, MY BASIS OF BEARING IS THESE SAID TWO FOUND MONUMENTS AND IS BASED ON SURVEY NO. 01-02-8. I ALSO RECOVERED THE SOUTHWEST CORNER, THE WEST 1/16 CORNER, THE SOUTH 1/4 CORNER, THE SOUTHWEST 1/16 CORNER AND THE CENTER 1/4 CORNER ALL OF SECTION 10.

THE LOCATION OF THE REMAINING RECTANGULAR CORNERS SHOWN ON THIS PLAT WHERE PROPORTIONED BASED ON THE PREVIOUSLY FOUND MONUMENTS.

THE DEED DESCRIBED ON REEL 376 PAGE 0311 AND RECORDED AS DOCUMENT NO. 2000-3760311 (TRANER) OMITS ONE HALF THE RIGHT OF WAY DISTANCE OF W. HERMISTON AVE. I HELD ONE HALF THE RIGHT OF WAY DISTANCE AT 30.00 FEET AS PER DEED DESCRIBED ON REEL 334 PAGE 0403 AND RECORDED AS DOCUMENT NO.

THIS SURVEY WAS ACCOMPLISHED UTILIZING THE TOPCON HYPER SYSTEM WITH A LEGACY-H RECEIVER. AN AUTONOMOUS POSITION WAS GENERATED ON THE BASE UNIT AND THE TWO PREVIOUSLY MENTIONED FOUND MONUMENTS MARKING THE WEST 1/4 CORNER AND THE SOUTH 1/16 CORNER BOTH OF SECTION 10 WERE SUBSEQUENTLY USED FOR LOCALIZING THE SYSTEM. EACH CORNER AND FEATURE WAS THEN LOCATED OR SET ON A 20 SECOND EPOCH WITH A FIXED SOLUTION.
