

NARRATIVE

The purpose of this survey was to monument the adjusted boundary between Lots 11 and 12 of Millenium Estates - Phase Two Subdivision. The boundary lines were established from found record monuments of the Subdivision.

DESCRIPTIONS BEFORE BOUNDARY ADJUSTMENT

LOT 11 Lot 11 of Millenium Estates - Phase Two; within Government Lot 1, Section 10, T. 2 N., R. 32 E., W. M.; subject to all easements and restrictions applying as of the date of this adjustment.

LOT 12 Lot 12 of Millenium Estates - Phase Two; within Government Lot 1, Section 10, T. 2 N., R. 32 E., W. M.; subject to all easements and restrictions applying as of the date of this adjstment.

DESCRIPTIONS AFTER BOUNDARY ADJUSTMENT

LOT 11 Lot 11 of Millenium Estates - Phase Two; within Government Lot 1, Section 10, T. 2 N., R. 32 E., W. M., including the following described part of adjacent Lot 12: Beginning at the 5/8" iron rebar at the southwest corner of said Lot 11; thence along the line between said Lots 11 and 12 to the 5/8" iron rebar at the northeast corner of said Lot 12, N66'24'51'E. 120.48'; thence along the easterly line of said Lot 12 to a 5/8 iron rebar set by this survey, S0'17'06'E, 30.00'; thence to the point o' beginning, S80'38'56'W, 112.05'; subject to all easements and restrictions applying as of the date of this adjustment.

LOT 12 Lot 12 of Millenium Estates - Phase Two; within Government Lot 1, Section 10, T. 2 N., R. 32 E., W. M., except the following described part of said Lot 12: Beginning at the original $5/8^{\circ}$ iron rebar at the except the following described part of said Lot 12: Beginning at the original $5/8^{\circ}$ iron rebar southwesterly corner of Lot 11: thence along the line between Lots 11 and 12 to the original $5/8^{\circ}$ iron rebar at the northeast corner of said Lot 12.
