




NARRATIVE OF SURVEY

THIS SURVEY WAS PERFORMED AT THE REQUEST OF CHRIS HOPKINS, UNDER THE DIRECTION OF ST. FRANCIS CATHOLIC CHURCH BOARD, TO LOCATE AND MONUMENT THE BOUNDARIES AS REFERENCED IN BARGAIN AND SALE DEED, DOCUMENT NO. 2003-4380578, DATED 6/04/03, UMATILLA COUNTY RECORDS, LOCATED IN THE NE I/4 OF SECTION 2: TOWNSHIP 5 NORTH; RANGE 35, EAST OF THE WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON.

IN RESEARCHING THIS SURVEY I FIND THAT THERE ARE RECORDS OF PREVIOUS SUBDIVISIONS TO THIS PROPERTY. FURTHER RESEARCH REVEALED THAT THERE WAS A VACATION ORDINANCE, NO. 284, FOR ROWLEY'S ADDITION TO THE CITY OF FREEWATER, DATED APRIL 13, 1948, RECORDED IN BOOK 185, PAGE 321, CITY OF FREEWATER RECORDS. THIS PROPERTY ABUTS THE NORTH BOUNDARY OF CARY AND MILLS ADDITION TO THE CITY OF FREEWATER. RESEARCH REVEALED PREVIOUS WORK PERFORMED BY TOMKINS SURVEYING, KRUMBEIN ENGINEERING, WAYNE HARRIS, VICTOR MCLIND, AND C.H. STORMS. ALL REFERENCED DOCUMENTS WERE ENTERED INTO OUR BASE DRAWING, SEARCHED, AND TIED WHEN POSSIBLE. ALL WERE GIVEN WEIGHT IN EVALUATING THE RESOLUTION OF THE LOCATION OF THE CORNER MONUMENTS SET. THERE IS A STEEL FENCE POST SET AT THE LOCATION OF THE WESTERLY PIN LOCATION CALLED IN THE C.H. STORMS SURVEY, NO. Q-998-AX. NO MONUMENT WAS FOUND, A WITNESS CORNER WAS RESET 0.30' EAST OF THE TRUE LOCATION WHICH FALLS BELOW SURFACE CONCRETE BASE POURED AROUND THE FENCE POST. I AM IN AGREEMENT WITH THE AXLE SHAFT CALLED IN SURVEY 05-014-G, AND 07-12-B AS BEING 0.98' WEST OF THE OLD MILTON HIGHWAY AND THE NORTHWEST CORNER OF THE OLD ROWLEY'S ADDITION. I ALSO FIND THE MONUMENT SET AND CALLED IN SURVEY 07-12-B, BY TOMKINS, AND AM IN AGREEMENT WITH IT'S LOCATION, I FIND A IRON REBAR WITH YELLOW PLASTIC CAP STAMPED "USKH INC" 1.98 FEET NORTH, WHICH FITS AS THE SOUTHWEST CORNER OF ROWLEY'S ADDITION AND THE NORTHWEST CORNER OF CARY AND MILLS ADDITION. I FIND MONUMENTS SET BY HARRIS, SURVEY NO. 06-590-B DATED 12/8/58, AROUND THE INTERSECTION OF 11TH AND VINING, AND TO THE NORTH AND WEST, WHICH DO NOT FIT THE RECORDS I'VE FOUND. WITHOUT A NARRATIVE OR OTHER CORROBORATING EVIDENCE TO SHOW THE REASONING BEHIND WHAT WAS DONE IN THIS SURVEY, I AM SHOWING THAT THE MONUMENTS WERE FOUND AND THEIR RELATIVE LOCATIONS. I DO FIND AN AXLE SHAFT AT NEAR WHERE THE LINE OF THE HARRIS SURVEY RUNS SOUTH AND THE DEED CALLS TO THIS SURVEY INTERSECT. IT APPEARS TO BE APPROXIMATELY 0.44' SOUTH OF THE LINE OF THE DEED CALL, BUT OTHERWISE FITS. THERE IS AN EXISTING OLD FENCE THAT BOUNDS THE CHURCH PROPERTY IN THIS AREA, AND THIS SAME FENCE FITS THE MCLIND CORNER MENTIONED ABOVE, RUNS NORTH AND IS APPROX. 0.3' WEST OF THE INTERSECT WITH THE NORTH LINE OF THE CHURCH DEED CALLS, AS SHOWN ON THIS PLAT. THERE IS A CHAIN LINK FENCE ALONG THE SOUTHERNMOST LINE OWNED BY THE CHURCH THAT IS APPROXIMATELY 6.5 FEET NORTH OF THE SOUTHWEST CORNER OF THIS PORTION OF PROPERTY AROUND THE RECTORY.
