


NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF JOHN FENTON, FOR HIS FAMILY PROPERTIES, TO RE-ESTABLISH THE NORTHERLY BOUNDARY OF LOT 4 OF BLOCK E OF THE ADDITION TO THE ADDITION OF JACOBS ADDITION TO THE CITY OF PENDLETON

THERE ARE NOT A LOT OF SURVEYS ON RECORD FOR THIS AREA. THE SURVEYS THAT ARE ON RECORD WERE USED TO LOCATE EXISTING MONUMENTS, WHICH MANY SHOW REFERENCES TO THE RESERVATION BOUNDARY MONUMENTS OF RECORD, AS SHOWN ON THIS PLAT.

THIS SURVEY WAS PERFORMED WITH A SOKKIA GSR2700IS REAL TIME KINEMATIC GPS SYSTEM, WITH REDUNDANT CHECKS TO TIED CONTROL, AND A TOPCON 8203B ROBOTIC ELECTRONIC TOTAL STATION. BASIS OF BEARING WAS HELD FROM WELLS SURVEY 94-02-B FOR THE KNIGHTS OF PYTHIAS. USACE CORPSCON 6.0.1 WAS USED TO DETERMINE A COMBINED SCALE FACTOR OF 0.999886506 GROUND TO GRID. THE INVERSE OF THIS WAS APPLIED TO GET FROM GPS GRID DISTANCES TO GROUND DISTANCES.


