COMES NOW MICHAEL WAYNE NORTON AND CARRIE LEN NORTON, HUSBAND AND WIFE, HEREINAFTER REFEREED TO AS NORTON, AND LESLIE H. KAMM AND JUNE C. KAMM, HUSBAND AND WIFE, HEREINAFTER REFEREED TO AS KAMM, AND AGREE AS FOLLOWS:

- 1. THE PARTIES HERETO OWN ADJOINING PIECES OF PROPERTY IN SECTION 10, TOWNSHIP 4 NORTH, RANGE 29, EWM, UMATILLA COUNTY, OREGON.
- 2. THE NORTH-SOUTH BOUNDARY LINE BETWEEN THE PROPERTIES IS SEPARATED BY A FENCE LINE THAT THE PARTIES AGREE MAY NOT BE ON THE ACTUAL BOUNDARIES OF THE PROPERTY.
- 3. NEITHER PARTY DESIRES A SURVEY TO BE MADE AT THIS TIME, HOWEVER BOTH AGREE THAT THE FENCE LINES AS NOW CONSTITUTED SHOULD BE THE PROPERTY LINE.


