

RECORD OF SURVEY




NARRATIVE

THIS SURVEY WAS MADE AT THE REQUEST OF DUSTIN CURTISS TO MARK THE PROPERTY BOUNDARIES OF PROPERTY OWNED BY HIM. THE WARRANTY DEED USED IS RECORDED AS INSTRUMENT NO. 2012-5980539 UMATILLA COUNTY DEED RECORDS. ALL CONTROLLING MONUMENTS FOUND AND HELD ARE SHOWN. AS NOTED IN THE LEGEND THE BUILDING ON THE ADJACENT LOT ENCROACHES ONTO THE SURVEYED PROPERTY. THE SIDEWALK ON THE SOUTH SIDE OF THE PROPERTY ALONG CONCORD STREET ALSO ENCROACHES APPROX. 0.1' ONTO THE PROPERTY. AT THESE CORNERS A BRASS WASHER IN A LEAD PLUG WAS SET IN THE CONCRETE SIDEWALK. BLOCK 5 IS LOCATED IN TWO DIFFERENT ADDITIONS TO HELIX. THE EASTERLY SIDE IS IN THE ORIGINAL TOWN OF HELIX AND THE WESTERLY SIDE IS IN RICHMOND'S ADDITION. SINCE THE ADDITIONS SHARE BLOCK 5 IN COMMON AND FOR THE PURPOSE OF THIS SURVEY, JUNIOR-SENIOR RIGHTS WERE NOT CONSIDERED.

THIS SURVEY WAS MADE WITH A TWO PERSON CREW USING A TRIMBLE 5700 SERIES GPS BASE STATION AND A TRIMBLE R8 ROVER USING LOCAL CONTROL. IN AREAS WHERE THE GPS SIGNAL WAS OBSCURED A LEICA TPC 803 3" TOTAL STATION WAS USED.

LOCATION & CONTROL DIAGRAM


