

SURVEYOR'S NARRATIVE

THIS SURVEY WAS INITIALLY UNDERTAKEN IN DECEMBER OF 2012 AT THE REQUEST OF BRANDON T. CHRISTENSEN, AND WAS FILED WITH UMATILLA COUNTY RECORDS AS SURVEY NUMBER 13-005-B. THE PURPOSE OF THE SURVEY WAS TO MONUMENT THE PROPERTY AS DESCRIBED ON INSTRUMENT NUMBER 2012-5920562 AND INSTRUMENT NUMBER 2008-5400361

UPON FURTHER REVIEW IT WAS DETERMINED THAT THE SOUNDEST WAY TO COMPUTE THE LOCATION OF THE NORTH PROPERTY IS AS FOLLOWS: IN A DEED FROM BOOK 282 PAGE 10 OF UMATILLA COUNTY RECORDS WITH A DATE OF 20 OCTOBER 1965 IT STATES "THENCE AT RIGHT ANGLES TO THE EAST LINE OF SAID SECTION IN A WESTERLY DIRECTION A DISTANCE OF 1320 FEET MORE OR LESS TO THE WEST LINE OF SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION" I THEREFORE HELD THE NORTH LINE OF THE CHRISTENSEN PROPERTY AT A RIGHT ANGLE TO THE NORTH-SOUTH SECTION LINE OF SECTION 20. BY COMPUTING THE NORTH CHRISTENSEN PROPERTY AS FILED ON INSTRUMENT NUMBER 2008–5400361 IN UMATILLA COUNTY RECORDS. THE LEGAL DESCRIPTION FOR THE CHRISTENSEN PROPERTY AS FILED ON INSTRUMENT 2008-5400361 IN UMATILLA COUNTY RECORDS STATES "THENCE SOUTH ALONG SAID WEST LINE, 389.35 FEET, MORE OR LESS TO A POINT 485.59 FEET NORTH OF THE SOUTH LINE OF SAID SECTION 20, WHEN MEASURED ALONG THE WEST LINE OF THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 20. BY COMPUTING THE NORTH LINE OF THE CHRISTENSEN PROPERTY AT RIGHT ANGLES TO THE EAST SECTION LINE OF SECTION 20 IT WILL MAKE THE WEST LINE OF THE CHRISTENSEN PROPERTY AT 339.87 FEET AND NOT THE 389.35 FEET AS IS FILED WITH UMATILLA COUNTY.

THE FENCE LINE THAT IS ± 30 FEET SOUTH OF THE SOUTH PROPERTY LINE WAS DESCRIBED TO MYSELF BY BOTH CHRISTENSEN AND ORTEGA AS BEING IN THE INCORRECT LOCATION. THEY BOTH MENTIONED THAT A PREVIOUS PROPERTY OWNER BUILT THE FENCE IN ITS

CURRENT LOCATION WITHOUT REGARDS TO THE CORRECT LOCATION ON THE PROPERTY LINE.

THE FENCE LINE THAT IS ± 12 FEET SOUTH OF THE NORTH PROPERTY LINE WAS DESCRIBED TO MYSELF BY CHRISTENSEN THAT IS WAS NEWLY CONSTRUCTED WITHOUT REGARD TO THE CORRECT LOCATION ON THE PROPERTY LINE. THE SUBDIVISION OF SECTION 20 OF TOWNSHIP 4 NORTH, RANGE 28, EAST OF THE WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON WAS HELD FROM SURVEY NUMBER 97-169-B.

THE PROPERTY CORNERS OF THE CHRISTENSEN PROPERTY WERE ESTABLISHED AS FOLLOWS:

*THE NORTHEAST CORNER WAS CALCULATED FROM THE DEED DISTANCE OF 499.69' FROM THE SOUTH SECTION LINE OF SECTION 20 AND THE 33' ROW OF KELLER ROAD AS STATED IN INSTRUMENT NUMBER 2012-5920562.

*THE NORTHWEST CORNER WAS CALCULATED FROM THE DEED DISTANCE OF 499.69' FROM THE EAST AND SOUTH SECTION LINES OF SECTION 20 AS STATED IN INSTRUMENT NUMBER 2012-5920562. *THE SOUTHWEST CORNER WAS CALCULATED FROM THE DEED DISTANCE OF 499.69' FROM THE EAST SECTION LINE OF SECTION 20 AND THE 33' ROW

OF DESPAIN GULCH ROAD AS STATED IN INSTRUMENT NUMBER 2012-5920562. THE COMPUTED POSITION ALSO FITS REASONABLY WELL ON A FOUND

*THE SOUTHEAST CORNER WAS CALCULATED FROM THE 33' ROW'S OF BOTH KELLER ROAD AND DESPAIN GULCH ROAD AS STATED IN INSTRUMENT NUMBER 2012-5920562.


INSTRUMENT NUMBER 2008-5400361 *THE SOUTHEAST CORNER WAS CALCULATED FROM THE DEED DISTANCE OF 499.69' FROM THE SOUTH SECTION LINE OF SECTION 20 AND THE 33' ROW OF KELLER ROAD AS STATED IN INSTRUMENT NUMBER 2008-5400361.

*THE NORTHEAST CORNER WAS CALCULATED FROM THE DEED DISTANCE OF 342.01' FROM THE SOUTHEAST CORNER THAT WAS PREVIOUSLY CALCULATED AS STATED IN INSTRUMENT NUMBER 2008-5400361. THE COMPUTED POSITION ALSO FIT REASONABLY WELL ON A FOUND 1 1/4 INCH IRON PIPE. *THE NORTHWEST CORNER WAS CALCULATED FROM THE DEED DIRECTION OF RIGHT ANGLES TO THE EAST LINE OF SECTION 20 IN A WESTERLY DIRECTION TO THE WEST LINE OF THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 20 AS STATED IN BOOK 282 PAGE 10. *THE SOUTHWEST CORNER WAS CALCULATED FROM THE DEED DISTANCE OF 485.59' FROM THE SOUTH SECTION LINE OF SECTION 20 AND THE 33'

ROW OF DESPAIN GULCH ROAD AS STATED IN INSTRUMENT NUMBER 2008-5400361. *THE CENTER SOUTH CORNER WAS CALCULATED FROM THE DEED DISTANCE OF 820.31 FEET MORE OR LESS AS STATED IN INSTRUMENT NUMBER 2008-5400361 FROM THE SOUTHWEST CORNER TO THE WEST LINE OF THE PROPERTY AS DESCRIBED ON INSTRUMENT NUMBER 2012-5920562. THE COMPUTED POSITION ALSO FITS REASONABLY WELL ON A FOUND 1/2 INCH IRON ROD.

*THE CENTER NORTH CORNER WAS CALCULATED FROM THE DEED DISTANCE OF 499.69' FROM THE EAST AND SOUTH SECTION LINES OF SECTION 20 AS STATED IN INSTRUMENT NUMBER 2012-5920562.

THE BASIS OF BEARING OF THIS SURVEY ARE THE FOUND MONUMENTS MARKING THE NORTH 1/4 CORNER AND THE SOUTH 1/4 CORNER OF SECTION 20, TOWNSHIP 4 NORTH, RANGE 28, EAST OF THE WILLAMETTE MERIDIAN AND IS BASED ON SURVEY NUMBER 97-169-B. THIS SURVEY WAS ACCOMPLISHED UTILIZING 2 TRIMBLE R-B GNSS RECEIVERS. AN AUTONOMOUS POSITION WAS GENERATED ON THE BASE UNIT AND THE TWO PREVIOUSLY MENTIONED FOUND RECTANGULAR CORNERS WERE SUBSEQUENTLY USED FOR LOCALIZING THE SYSTEM, EACH CORNER WAS THEN LOCATED OR SET ON A 15 SECOND EPOCH WITH A FIXED SOLUTION.
