

NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF DENNIS HUGGINS TO SURVEY AND MONUMENT THE BOUNDARY OF PROPERTY OWNED BY WELTON AND MARGARET HUGGINS. THE PROPERTY IS DESCRIBED IN WARRANTY DEED RECORDED AS INSTRUMENT NO. 2001-3860389, UMATILLA COUNTY DEED RECORDS. SAID DEED DESCRIBES THE THE PROPERTY AS THE NORTH 5 FEET OF LOT 7, AND LOTS 8, 9, AND 10, BLOCK 12, OF THE ORIGINAL TOWN OF WESTON. BLOCK 12 AND SURROUNDING BLOCKS WERE SURVEYED PREVIOUSLY IN SURVEY NO. 11-106-C. SEE SAID SURVEY FOR INFORMATION ON THE VARIOUS ADDITIONS, MONUMENTS, AND CONTROLLING CORNERS.

AS SHOWN ON THIS SURVEY THERE IS A CMU BLOCK WALL AND CONCRETE RIP-RAP WALL ALONG THE WESTERLY PROPERTY LINE. THE PROPERTY CORNERS WERE SET ON 07-09-14. AT THIS TIME THE CMU BLOCK RETAINING WALL AND CMU WALL WERE GOING TO BE REMOVED THAT DAY, AND THE GROUND LEVELED OUT TO INSTALL A NEW PRECAST CONCRETE BLOCK WALL ALONG THE PROPERTY LINE. THE SOUTHWEST CORNER OF THE PROPERTY WAS NOT SET AS IT WOULD HAVE BEEN DESTROYED.

THIS SURVEY WAS MADE WITH A TWO PERSON CREW USING A LEICA TPC 803 3" TOTAL STATION AND A COMBINATION OF RADIAL AND CLOSED TRAVERSE. MONUMENTS SET WERE VERIFIED BY SEPARATE BACKSIGHT OBSERVATIONS.

- FOUND MAG SPIKE WITH 1 1/2" ALUMINUM WASHER STAMPED "WELLS SURVEYING 54657PLS" AT SURFACE OF PAVEMENT PER SURVEY NO. 11-106-C.
- CALCULATED POINT ONLY. NOTHING FOUND OR SET.
- MONUMENTS FOUND AND DESCRIBED ON SURVEY 11-106-C. NOT HELD.
- RECORD DIMENSION AS REPORTED ON SURVEY NO. 11-106-C. THESE DIMENSIONS ARE ORIGINAL PLAT RECORDS FOR THE VARIOUS ADDITIONS TO THE CITY OF WESTON. FOR FURTHER INFORMATION AND EXPLAINATION SEE SAID SURVEY.
