## SURVEYOR'S NARRATIVE

THIS SURVEY WAS UNDERTAKEN IN JANUARY OF 2018 AT THE REQUEST OF DENIS AND DAVID HYATT UNDER THE DIRECTION OF MARK MORGAN CITY OF HERMISTON ASSISTANT CITY MANAGER, TO LAYOUT, COMPOSE A METES AND BOUNDS LEGAL DESCRIPTION AND FILE A RECORD OF SURVEY FOR A LEASE AGREEMENT ON A TRACT OF LAND AT THE HERMISTON MUNICIPAL AIRPORT, LOCATED IN THE NORTHWEST ONE-QUARTER OF SECTION 13, TOWNSHIP 4 NORTH, RANGE 28 EAST OF THE WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON.

IN 2013 LS 61420 PERFORMED A RECORD OF SURVEY IN THE GENERAL VICINITY, SEE SURVEY NUMBER 13-566-B, FOR THE HERMISTON MUNICIPAL AIRPORT

IN 2008 LS 43406 PERFORMED A RECORD OF SURVEY IN THE GENERAL VICINITY, SEE SURVEY NUMBER 08-75-B, FOR THE HERMISTON MUNICIPAL AIRPORT FOR A LEASE AGREEMENT.

I WAS ABLE TO RECOVER BOTH THE NORTHEASTERLY AND SOUTHWESTERLY CENTERLINE RUNWAY MONUMENTS. BOTH OF THESE POINTS ARE MONUMENTED WITH A 3 INCH BRASS DISK STAMPED AS SHOWN. I HELD THESE 2 MONUMENTS AND COMPUTED A STATION AND OFFSET TO THE LEASE AGREEMENT AREA AS WHAT IS SHOWN UPON THE FACE OF THIS RECORD OF SURVEY.

THE EXISTING HANGER THAT IS LOCATED TO THE SOUTHWEST OF THE PROPOSED LEASE AGREEMENT WAS MAPPED, I THEN COMPUTED THE SOUTHWESTERLY LINE OF THE PROPOSED LEASE AGREEMENT AT AN OFFSET OF 20 FEET TO THE NORTHEAST OF THE NORTHEASTERLY LINE OF THE SAID EXISTING HANGER. I THEN UTILIZED THE "PROPOSED HANGER LAYOUT" DOCUMENT DATED 1/9/2018 AS PROVIDED MY MARK MORGAN CITY OF HERMISTON ASSISTANT CITY MANAGER TO COMPUTE THE REMAINING SIDES OF THE PROPOSED LEASE AGREEMENT AREA. A TIE WAS THEN MEASURED TO THE NORTHWEST SECTION CORNER OF SECTION 13, TOWNSHIP 4 NORTH, RANGE 28, EAST OF THE WILLAMETTE MERIDIAN.


THE BASIS OF BEARING OF THIS SURVEY ARE THE 2 FOUND 3 INCH BRASS DISKS MARKING THE SOUTHWEST AND THE NORTHEAST CENTERLINE LOCATIONS OF THE THE HERMISTON MUNICIPAL AIRPORT RUNWAY, AND IS BASED UPON OREGON NORTH ZONE STATE PLANE COORDINATES (3601) INTERNATIONAL FEET.


THIS SURVEY WAS ACCOMPLISHED UTILIZING 2 TRIMBLE R-10 GNSS RECEIVERS. AN AUTONOMOUS POSITION WAS GENERATED ON THE BASE UNIT AND THE TWO PREVIOUSLY MENTIONED 3 INCH BRASS DISK MONUMENTS IDENTIFYING THE CENTERLINE OF THE RUNWAY WERE SUBSEQUENTLY USED FOR LOCALIZING THE SYSTEM, ALL FEATURES HAVE BEEN LOCATED OR SET ON A 15 SECOND EPOCH WITH A FIXED SOLUTION.

CONTAINING 5355.00 SQUARE FEET.
