

THIS PROPERTY LINE ADJUSTMENT SURVEY WAS MADE AT THE REQUEST OF MARVIN MILLS TO ADJUST THE BOUNDARIES OF TWO TAXES LOTS OWNED BY MILLS BROTHERS, LLC. AN IRRIGATED CIRCLE OCCUPIES TAX LOT 2800, AND THE FARMED AREA CUTS A PORTION OF TAX LOT 2900 OFF AS SHOWN. THE EXISTING FENCE LINE HAS REFLECTED THIS FOR YEARS, AND WAS HELD FOR THE ADJUSTMENT LINE AT THE NORTHEAST CORNER OF TAX LOT 2900 AS SHOWN.

## ALL RECORD MONUMENTS FOUND AND HELD ARE NOTED.

THIS SURVEY WAS MADE USING A TRIMBLE R8 GPS RECEIVER OPERATED OVER THE ORGN REAL TIME GPS NETWORK. ALL CONTROLLING TIES AND MONUMENT SETS WERE VERIFIED BY REDUNDANT OBSERVATIONS.
