SURVEYOR'S NARRATIVE

THIS SURVEY WAS UNDERTAKEN IN MAY OF 2018 AT THE REQUEST OF RICK ROSS UNDER THE DIRECTION OF MARK MORGAN CITY OF HERMISTON ASSISTANT CITY MANAGER, TO MONUMENT THE CORNERS OF THE LEASE AGREEMENT, COMPOSE A METES AND BOUNDS LEGAL DESCRIPTION AND FILE A RECORD OF SURVEY FOR SAID LEASE AGREEMENT ON A TRACT OF LAND AT THE HERMISTON MUNICIPAL AIRPORT, LOCATED IN THE NORTHWEST ONE-QUARTER OF SECTION 13, TOWNSHIP 4 NORTH, RANGE 28 EAST OF THE WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON.

IN 2018 I PREVIOUSLY PERFORMED A RECORD OF SURVEY FOR A LEASE AGREEMENT ON A TRACT OF LAND LOCATED ON THE HERMISTON MUNICIPAL AIRPORT PROPERTY, IN THAT SURVEY I TIED IN BOTH THE EASTERLY AND WESTERLY CENTERLINE OF RUNWAY MONUMENTS AS WELL AS THE NORTHWEST CORNER OF SECTION 13, TOWNSHIP 4 NORTH, RANGE 28, EAST OF THE WILLAMETTE MERIDIAN.

IN 2013 LS 61420 PERFORMED A RECORD OF SURVEY IN THE GENERAL VICINITY, SEE SURVEY NUMBER 13-566-B, FOR THE HERMISTON MUNICIPAL AIRPORT PERIMETER FENCE IMPROVEMENTS PROJECT.

IN 2008 LS 43406 PERFORMED A RECORD OF SURVEY IN THE GENERAL VICINITY, SEE SURVEY NUMBER 08-75-B, FOR THE HERMISTON MUNICIPAL AIRPORT FOR A LEASE AGREEMENT.

I MAPPED BOTH THE SOUTHERLY AND NORTHERLY EDGE OF THE ROAD THAT SERVICES THE HERMISTON MUNICIPAL AIRPORT AS WELL AS THE CENTERLINE OF THE HERMISTON FEED CANAL. THE SOUTHWEST CORNER OF THE LEASE AGREEMENT WAS COMPUTED AT A 20 FOOT OFFSET TO THE POINT OF CURVATURE OF THE NORTHERLY EDGE OF THE ASPHALT SERVICE ROAD. THE NORTHWEST CORNER WAS COMPUTED AT THE SOUTHEASTERLY RIGHT OF WAY LINE OF THE HERMISTON FEED CANAL AND NORMAL TO THE SOUTHWEST CORNER AS PREVIOUSLY MENTIONED. THE NORTHEAST CORNER WAS COMPUTED AT THE SOUTHEASTERLY RIGHT OF WAY LINE OF THE HERMISTON FEED CANAL AT A LONG CHORD BEARING AND DISTANCE OF N 43°01'59" E, 35.24 FEET. THE SOUTHEAST CORNER WAS COMPUTED AT A 20 FOOT OFFSET TO THE NORTHERLY EDGE OF THE GRAVEL SERVICE ROAD AND AT 200.00 FEET FROM THE SOUTHWEST CORNER PREVIOUSLY MENTIONED. THE AREA OF THE LEASE AGREEMENT IS 46,167.86 SQUARE FEET.

THE BASIS OF BEARING OF THIS SURVEY ARE THE 2 FQUND 3 INCH BRASS DISKS MARKING THE SOUTHWEST AND THE NORTHEAST CENTERLINE LOCATIONS OF THE THE HERMISTON MUNICIPAL AIRPORT RUNWAY, AND IS BASED UPON OREGON NORTH ZONE STATE PLANE COORDINATES (3601) INTERNATIONAL FEET.

THIS SURVEY WAS ACCOMPLISHED UTILIZING 2 TRIMBLE R-10 GNSS RECEIVERS. AN AUTONOMOUS POSITION WAS GENERATED ON THE BASE UNIT AND THE TWO PREVIOUSLY MENTIONED 3 INCH BRASS DISK MONUMENTS IDENTIFYING THE CENTERLINE OF THE RUNWAY WERE SUBSEQUENTLY USED FOR LOCALIZING THE SYSTEM, ALL FEATURES HAVE BEEN LOCATED OR SET ON A 15 SECOND EPOCH WITH A FIXED SOLUTION.




