


NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS DOCUMENT A PROPERTY LINE ADJUSTMENT BETWEEN TAX LOTS 1102 AND 1200 OF ASSESSOR MAP NO. 4N 28 03D. THE SURVEY WAS MADE AND DESCRIPTIONS PREPARED AT THE REQUEST OF MR. BRUCE HUMPHREY.

CONTROL FOR THE SURVEY IS BASED ON SURVEY NUMBERS 00-080-C, 06-445-B, 09-109-B, 13-563-B AND PARTITION PLAT NO. 2003-13. THESE SURVEYS WERE MADE BY MYSELF BEGINNING IN THE YEAR 2000. I TIED INTO CERTAIN MONUMENTS REPORTED ON THOSE SURVEYS AND USED THOSE MONUMENTS TO CONTROL THE CURRENT PROPERTY LINE ADJUSTMENT

WHEN SURVEY NO. 00-080-C WAS MADE IN 2000. I TIED THE PHYSICAL LOCATION OF THE HERMISTION DRAIN DITCH, (A.K.A. HERMISTON IRRIGATION CANAL), AND REPORTED IT'S CENTERLINE BECAUSE THE LEGAL DESCRIPTIONS CALLED FOR THE CENTERLINE OF THE DITCH AS THE BOUNDARY. PORTIONS OF THE DITCH HAVE BEEN FILLED IN AS OF NOVEMBER, 2018, BUT THE UNFILLED PORTIONS OF THE ORIGINAL DITCH MATCH SURVEY NO. 00-080-C. I NOTE THIS FACT IN THIS NARRATIVE BECAUSE CERTAIN SURVEYS MADE SOUTH OF THE DITCH CENTERLINE AFTER SURVEY NO. 00-080-C USED A "GENERALIZED" DITCH CENTERLINE LOCATION WHICH DOES NOT FIT THE EXISTING DITCH CENTERLINE. THE "GENERALIZED" DITCH CENTERLINE LOCATION WAS REPORTED ON SURVEY NO. C-8-C.

DESCRIPTIONS FOR THE PROPERTY LINE ADJUSTMENT ARE PREPARED SEPARATELY FOR CONVEYANCE PURPOSES. EXISTING AND RESULTING AREAS FOR EACH PROPERTY LINE ADJUSTMENT ARE SHOWN IN THE AREA SUMMARY ON THIS RECORD OF SURVEY.

THE SURVEY WAS MADE WITH TRIMBLE GEODETIC GPS RECEIVERS OPERATED IN REAL TIME KINEMATIC MODE. CONTROL POINTS AND NEW MONUMENTS SET WERE VERIFIED BY SEPARATE
