
A SURVEY OF LOTS 8 AND 12, BLOCK E, TOWN OF UKIAH UMATILLA COUNTY, OREGON



Note: This monument has been paved over by ODOT. The metal detector indicates the monument is still present but I did not dig it up. This point was calculated using the record data from my prior survey O7-O41-B.

NARRATIVE OF SURVEY

This survey was performed at the request of Donna Neumann on behalf of the Ukiah School District. The purpose of the survey was to locate and monument the corners of lots 8 and 12 of Block E, Town of Ukiah. I have performed two prior surveys in Block E under which I examined the controlling monuments established under survey 0-2-C. In my prior surveys I concluded that the monuments from survey 0-2-C had been properly established and therefore held them as the proper control for this block. I hold them again for this survey.

The greatest difference between my measurements on this survey and those of my prior surveys was 0.05 feet. I have therefore reported the measurements for this survey as both record and measured dimensions.


This survey was performed with a Trimble R7/R8 RTK GPS system.
