

THE PURPOSE OF THIS RECORD OF SURVEY IS TO ESTABLISH THE PROPERTY LINES AND SET ANY MISSING PROPERTY CORNERS FOR THE SUBJECT PARCEL, INDICATED IN CORPORATION WARRANTY DEED RECORDED IN BOOK 27, PAGE 132-134, UMATIALLA CO. DEED RECORDS, AT THE REQUEST OF TOBY CARLSON.

MONUMENTS WERE SEARCHED FOR AT ALL EXTERIOR CORNERS OF THE SUBJECT PARCEL. FOUND MONUMENTS SHOWN HEREON WERE HELD FOR THE TRUE BOUNDARY OF THE SUBJECT PARCEL, THESE MONUMENTS ORIGINATE FROM RECORDED SURVEYS REFERENCED AS R1, R2 AND RR. MISSING CORNER POSITIONS ALONG THE EXTERIOR BOUNDARY OF THE SUBJECT PROPERTY WERE EITHER COMPUTED BY THE RECORD LEGAL DESCRIPTIONS OR SURVEYS OF RECORD AS STATED BELOW.

NO MONUMENT WAS FOUND AT THE SOUTHWEST CORNER OF THE SUBJECT PROPERTY. POSITION WAS RESET ON THE PROJECTION OF THE MONUMENTS FOUND ON THE EAST LINE OF SAID PROPERTY AT THE RECORD DISTANCE OF 43.27' IN (R1). THE NORTH LINE OF THE SUBJECT PROPERTY WAS ESTABLISHED PARALLEL WITH THE MEASURED CENTERLINE OF EMIGRANT AVENUE FROM THE NORTHEAST CORNER AS COMPUTED FROM THE FOUND MONUMENTS ALONG SAID EAST LINE.

THE CENTERLINE OF THE RAILROAD R/W WAS ESTABLISHED AT A 50.00 FEET OFFSET FROM THE FOUND MONUMENTS FROM (R1) AND (R2). THE START OF THE CURVE FOUND WITHIN THE BOUNDARIES OF LOT 13, BLOCK 83, RESERVE ADDITION WAS ESTABLISHED AT THE PROJECTION OF THE R/W CENTERLINE 174.70' PAST THE PERPENDICULAR INTERSECTION OF A LINE DRAWN FROM THE MONUMENT AT THE SI OF EMIGRANT AND SW 11TH (OAK) ST TO THE R/W Q, AS SHOWN ON (RR).

THE PHYSICAL LOCATION OF THE CENTERLINE OF THE MAIN RAIL IS CONSISTENT WITH THE MONUMENTS OF RECORD AND OUR COMPUTED RIGHT-OF-WAY CENTERLINE.

THE CENTERLINE OF SW 11TH (OAK) ST WAS ESTABLISHED AT RIGHT ANGLES TO THE MEASURED CENTERLINE OF EMIGRANT AVENUE AS SHOWN HEREON. NO VACATION DOCUMENTATION FOR THIS PORTION OF 11TH ST LYING SOUTHERLY OF EMIGRANT AVENUE RIGHT-OF-WAY AND LYING NORTHERLY OF THE UNION PACIFIC RAILROAD (FORMERLY OREGON WASHINGTON RAILROAD & NAVIGATION COMPANY) RIGHT-OF-WAY WERE FOUND TO EXIST. SAID PORTION OF SW 11TH ST IS BELIEVED TO STILL BE PUBLIC R/W.
