


## RECORD OF SURVEY

LOCATED IN THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 11, TOWNSHIP 4 NORTH, RANGE 28 EAST, WILLAMETTE MERIDIAN. CITY OF HERMISTON, UMATILLA COUNTY, OREGON

## BASIS OF BEARINGS

OREGON COORDINATE SYSTEM NORTH ZONE GRID BEARING: NO0°54'46"W FROM MAG NAIL AT BENT 3/4-INCH IRON ROD FOUND AT THE INTERSECTION OF E MAIN STREET AND NE SEVENTH STREET AND THE 1/2-INCH IRON PIPE IN MONUMENT CASE AT THE INTERSECTION OF E RIDGEWAY AVENUE AND SEVENTH STREET. DISTANCES SHOWN ARE GROUND DISTANCES. TO ACHIEVE GRID DISTANCES, SCALE THE DISTANCES SHOWN BY A COMBINED SCALE FACTOR OF 0.99994503

### NARRATIVE

THIS SURVEY WAS MADE AT THE REQUEST OF HORIZON PROJECT TO RETRACE AND MARK THE BOUNDARIES OF THE PROPERTY DESCRIBED AS:

### TRACT I

LOT 6, (EXCEPTING THEREFROM THE EAST 16 FEET) AND THE EAST HALF OF LOT 7, BLOCK 9, NEWPORT ADDITION, TO THE TOWN OF HERMISTON, UMATILLA COUNTY, OREGON.

### TRACT III

THE WEST HALF OF LOT 7 AND ALL OF LOT 8, BLOCK 9, NEWPORT ADDITION TO THE TOWN, NOW CITY OF HERMISTON, UMATILLA COUNTY, OREGON;

EXCEPTING THEREFROM THE SOUTH 35 FEET THEREOF.


### TRACT III

THE SOUTH 35 FEET OF THE WEST HALF OF LOT 7 AND THE SOUTH 35 FEET OF LOT 8, BLOCK 9, NEWPORT ADDITION TO THE TOWN, NOW CITY OF HERMISTON, UMATILLA COUNTY, OREGON.

THIS DESCRIBES THE SAME PROPERTY THAT WOULD BE DESCRIBED BY A COMBINATION OF THE DEEDS AS REFERENCED IN THE SURVEY REFERENCE TABLE ON SHEET 1.

THE ADJACENT BLOCK ON THE NORTH SIDE OF E MAIN STREET WAS SURVEYED IN 1986 BY DENNIS EDWARDS AS SHOWN ON C.S. #86-127-A (R2). THE FOUND 1/2-INCH IRON PIPE AND NAIL IN MONUMENT CASE WAS HELD AT THE CENTERLINE INTERSECTION OF FOURTH STREET AND NEWPORT AVENUE, AND THE CALCULATED POSITION OF THE MONUMENT AT THE SW RIGHT-OF-WAY CORNER OF FOURTH STREET AND E GLADYS AVENUE WERE HELD TO RE-ESTABLISH THE POSITION OF THE 1-INCH IRON BAR AT THE CENTERLINE INTERSECTION OF E MAIN STREET AND FOURTH STREET AS SHOWN ON THE 1986 EDWARDS SURVEY. THE RECORD DISTANCE PER (R2) SOUTH ALONG SAID CENTERLINE OF 299.07 FEET WAS HELD. AN EXTENSIVE SEARCH WAS PERFORMED AND SEVERAL MONUMENTS WERE LOCATED WITHIN THE SW 1/4 OF SECTION 11 THAT CLOSELY MATCH A 2005 SURVEY BY DENNIS EDWARDS AS SHOWN ON C.S. #05-013-G (R5), AND THE CALCULATED POSITION PER THAT SURVEY WAS HELD FOR THE THE 3/4-INCH IRON PIPE AT THE SW RIGHT-OF-WAY CORNER OF FOURTH STREET AND E GLADYS AVENUE AS SHOWN. THE POSITION OF THE CENTERLINE INTERSECTION OF SIXTH STREET WITH MAIN STREET WAS COMPUTED BY TURNING THE RECORD ANGLE AND DISTANCE AS SHOWN ON A 2000 SURVEY BY WILLIAM WELLS PER C.S. #00-146-B (R4) FROM THE CENTERLINE OF SEVENTH STREET BETWEEN THE FOUND MAG NAIL AT THE BENT 3/4-INCH IRON PIN AT ITS INTERSECTION WITH E MAIN STREET, AND THE FOUND NAIL IN THE CENTER OF A 2-INCH PIPE AT ITS INTERSECTION WITH E RIDGEWAY AVENUE. SAID CALCULATED POSITION CLOSELY MATCHES WITH THE RECORD MEASUREMENT (R4) TO A FOUND HEX BOLT AT THE CENTERLINE OF E HURLBURT AVENUE AND SIXTH STREET, WHICH WE HELD FOR THIS INTERSECTION. ALL OTHER STREET CENTERLINE INTERSECTION POSITIONS WERE CALCULATED BY SINGLE PROPORTIONATE MEASURE AS COMPARED TO THE ORIGINAL PLAT (R1) PER BOOK 2, PAGE 76.

THIS SURVEY WAS PERFORMED AS A REAL TIME KINEMATICS SURVEY USING TRIMBLE R12; AND R10 RECEIVERS WITH A STANDARD ACCURACY OF 8MM + 0.5 PPM HORIZINTAL AND 15MM + 0.5 PPM VERTICAL. MONUMENTS SHOWN FOR THIS SURVEY WERE VISITED IN FEBRUARY AND MARCH 2022.
