




LEGEND

THIS SURVEY WAS MADE AT THE REQUEST OF JOE FAUSTI TO SURVEY THE OVERALL BOUNDARY OF DEED NO. 2019—6880012. THE PROPERTY CONSISTS OF 2 LOTS, AND A PORTION OF VACATED ARMAN STREET AS DEPICTED. THE BLOCKS AND STREETS IN THIS AREA WERE PREVIOUSLY COMPUTED IN SURVEY NO. 11—106—C WHICH WAS HELD FOR THIS SURVEY. THERE IS AN ENCROACHMENT FROM THE HOUSE ON LOT 3 ONTO LOT 2 AS SHOWN. AND NOTED IN THE NOTE BELOW THE DETAIL.

THIS SURVEY WAS MADE USING A LEICA GS14 REALTIME GPS RECEIVER OPERATED OVER THE OREGON REALTIME GNSS NETWORK. MONUMENTS SET AND CONTROLLING TIES WERE MEASURED MULTIPLE TIMES FOR REDUNDANCY.





LOTS 1, 2, AND 3 WERE ALL OWNED BY THE METHODIST EPISCOPAL CHURCH. LOTS 1 AND 2 CONTAINING THE CHURCH, AND LOT 3 CONTAINING THE MINISTERS HOUSE. BOTH BUILDINGS STAND TODAY. I BELIEVE BECAUSE OF THIS OWNERSHIP NO CARE WAS GIVEN WHEN THE MINISTERS HOUSE WAS BUILD IN REGARDS TO THE LOT LINE BETWEEN LOTS 2 AND 3. LOT 3 WAS SOLD SEPARATELY FROM LOTS 1 AND 2 AND IS IN DIFFERENT OWNERSHIP. BECAUSE OF THIS THE HOUSE ON LOT 3 ENCROACHES ONTO LOT 2 AS SHOWN.
