


RECORD OF SURVEY/PROPERTY LINE ADJUSTMENT LOCATED IN THE NE 1/4 SECTION 24, T5N, R27E, AND THE NW 1/4 SECTION 19, T5N, R28E, W.M.





NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO ADJUST THE BOUNDARIES OF TAX LOT 504 PER ASSESSORS MAP 5N27 AND TAX LOT 2200 PER ASSESSORS MAP 5N28 FOR THE EXPANSION OF THE EXISTING ELECTRICAL SUBSTATION ON TAX LOT 504.

THE BASIS OF BEARINGS IS PER GPS OBSERVATION BASED UPON OREGON STATE PLANE COORDINATES, NORTH ZONE, NAD 83 (2011).

THE NORTH LINE OF SECTION 19 WAS ESTABLISHED PER FOUND AND HELD MONUMENTATION MARKING THE SECTION CORNER AND THE NORTH QUARTER CORNER AS SHOWN. THE NORTH-SOUTH LINE BETWEEN SECTIONS 19 AND 24 WAS ESTABLISHED PER FOUND AND HELD MONUMENTATION MARKING THE SECTION CORNER AND THE QUARTER CORNER BETWEEN SAID SECTIONS. THE NORTH LINE OF SECTION 24 (ALSO THE NORTH LINE OF THE EXISTING UEC TRACT) WAS ESTABLISHED FROM FOUND AND HELD MONUMENTATION AT THE SECTION CORNER AND A 2" IRON PIPE ALONG THE SECTION LINE AS SHOWN ON SURVEY J-053-AX.

LEGAL DESCRIPTION TL 2200-AREA OF ADJUSTMENT

A TRACT OF LAND LOCATED IN THE NORTHWEST QUARTER OF SECTION 19, TOWNSHIP 5 NORTH, RANGE 28 EAST OF THE WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A 2 1/2" BRASS CAP MARKING THE CORNER OF SECTIONS 13 AND 24, TOWNSHIP 5 NORTH, RANGE 27 EAST, AND SECTIONS 18 AND 19, TOWNSHIP 5 NORTH, RANGE 28 EAST OF THE WILLAMETTE MERIDIAN, THENCE NORTH 89°15'39" EAST ALONG THE SECTION LINE, 202.16 FEET; THENCE LEAVING SAID SECTION LINE, SOUTH 00°00'01" WEST, 358.54 FEET; THENCE SOUTH 30°37'30" WEST, 165.27 FEET; THENCE SOUTH 89°04'17" WEST, 109.71 FEET TO THE NORTH-SOUTH SECTION LINE; THENCE NORTH 00°56'43" WEST ALONG SAID NORTH-SOUTH SECTION LINE, 500.00 FEET TO SAID SECTION CORNER AND THE POINT OF BEGINNING.

BEGINNING AT A 2 1/2" BRASS CAP MARKING THE CORNER OF SECTIONS 13 AND 24, TOWNSHIP 5 NORTH, RANGE 27 EAST, AND SECTIONS 18 AND 19, TOWNSHIP 5 NORTH, RANGE 28 EAST OF THE WILLAMETTE MERIDIAN, THENCE NORTH 89°15'39" EAST ALONG THE SECTION LINE, 202.16 FEET; THENCE LEAVING SAID SECTION LINE, SOUTH 00°00'01" WEST, 358.54 FEET; THENCE SOUTH 30°37'30" WEST, 165.27 FEET; THENCE SOUTH 89°04'17" WEST, 109.71 FEET TO THE NORTH-SOUTH SECTION LINE; THENCE CONTINUING SOUTH 89°04'17" WEST, 200.00 FEET; THENCE PARALLEL WITH SAID NORTH-SOUTH SECTION LINE, NORTH 00°56'43" WEST, 500.00 FEET TO THE NORTH LINE OF SAID SECTION 24; THENCE NORTH 89°04'17" EAST ALONG SAID NORTH SECTION LINE, 200.00 FEET TO THE POINT OF BEGINNING


