EASEMENTS ARE GRANTED TO PLACE, CONSTRUCT, OPERATE, REPAIR MAIINTAIN, RELOCATE AND REPLACE ELECTRIC TRANSMISSION OR DISTRIBUTION LINE OR SYSTEM, INCLUDING THE RIGHT TO TRIM TREES ENDANGERING OVERHEAD LINES. SURVEYOR'S NOTE: THE ONLY VISIBLE UEC LINE IN THE EASEMENT AREA IS THE OVERHEAD SERVICE LINE NEAR THE NORTH SIDE OF THE EASEMENT AREA.
- (B) EXISTING 15' EASEMENT FOR INGRESS-EGRESS AND IRRIGATION LINE, DATED MARCH 27, 2001, INSTRUMENT NO. 2001-3850451, UMATILLA COUNTY OFFICE OF RECORDS. IRRIGATION PIPE IS INSTALLED IN EASEMENT.

THIS PROPERTY LINE ADJUSTMENT SURVEY WAS MADE AT THE REQUEST OF KALVIN B. GARTON TO DOCUMMENT A PROPERTY LINE ADJUSTMENT BETWEEN PARCELS 2 AND 3 OF PARTITION PLAT NO. 2022-11. THE TAX LOT NUMBERS FOR THE ADJUSTED TRACTS AND THE LAND AREA ADJUTED ARE SHOWN ON THIS MAP. LEGAL DESCRIPTIONS FOR AREA ADJUSTED AND RESULTING TRACT DESCRIPTION ARE PREPARED ON SEPARATE PAGES.

PARTITION PLAT NO. 2022-11 IS THE BASIS OF SURVEY CONTROL FOR THIS SURVEY, I SET 2 NEW MONUMENTS TO DEFINE THE BOUNDARY OF THE ADJUSTED TRACTS.

THE SURVEY WAS MADE WITH A GEODETIC GPS RECEIVER CONNECTED TO THE OREGON REAL TIME NETWORK. CONTOLLING MONUMENTS TIED AND NEW MONUMENTS SET WERE VERIFIED BY REDUNDANT OBSERVATIONS.
