### SURVEY NARRATIVE

THIS SURVEY IS BEING PREPARED AT THE REQUEST OF DAKOTA SCHNEIDER OF S & H CONSTRUCTION, INC. THE PURPOSE IS TO MARK THE BOUNDARIES OF STATUTORY WARRANTY DEED RECORDED UNDER INSTRUMENT NUMBER 2023-00640, EXCEPTING THEREFROM THAT PORTION COVERED BY EASEMENT CONVEYED TO THE CITY OF STANFIELD PER INSTRUMENT NUMBER 2013-6080364, OFFICE OF COUNTY RECORDS, UMATILLA COUNTY, OREGON, AND SURVEYED IN 11-119-C (R4).

I HELD THE FOUND MONUMENTATION AS NOTED AND COMPUTED THE RECORD LOTS OF STANFIELD ORCHARD OUTLOTS BY PROPORTION USING RECORD PLAT DATA. THIS IS CONSISTENT WITH METHODS USED IN THE RECORDS OF REFERENCE NOTED HEREON. EASEMENT PER INSTRUMENT NUMBER 2013-6080364 ORIGINATES FROM DATA PER SURVEY 11-119-C. I HELD FOUND MONUMENTS PER SAID SURVEY (ALSO SEE SURVEY NOTES).

ONLY THE SOUTHEAST CORNER OF SURVEY 08-066-B WAS FOUND IN THIS SURVEY. THE SOUTHWEST, NORTHWEST, AND NORTHEAST CORNERS OF SAID SURVEY WERE NOT FOUND. THEY MAY HAVE BEEN REMOVED BY FENCE CONSTRUCTION AS POSTS OCCUPY THE COMPUTED CORNER LOCATIONS.

THIS SURVEY WAS PERFORMED USING TWO TOPCON HIPER HR GNSS UNITS OPERATED IN RTK MODE. THE BASIS OF BEARING IS THE CENTER OF COE AVENUE PER R2, R3, & R5. DISTANCES ARE GROUND, INTERNATIONAL FEET.
