

THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 30, TOWNSHIP 4 NORTH, RANGE 28 EAST, LYING SOUTH OF THE UMATILLA RIVER AS IT RAN ON JUNE 12,

EXCEPTING THE SOUTH 575 FEET THEREOF.

ALL BEING EAST OF THE WILLAMETTE MERIDIAN, IN THE COUNTY A UMATILLA, AND STATE OF OREGON.

EXCEPTING ANY AND ALL WATER RIGHTS OF WAY AND ROADS.

ALL THAT PORTION OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 30, TOWNSHIP 4 NORTH, RANGE 28 EAST, WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON, LYING SOUTHERLY OF THE UMATILLA RIVER.

EXCEPTING THEREFROM ANY PORTION LYING WITHIN THE COUNTY ROAD RIGHT OF WAY.

TRACT_II

ALL THAT PORTION OF THE NORTHEAST QUARTER OF SECTION 30, TOWNSHIP 4 NORTH, RANGE 28 EAST, WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON, DESCRIBED AS FOLLOWS;

BEGINNING AT THE NORTHEAST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 30; THENCE SOUTH 0'40'44" EAST ALONG THE EAST LINE OF SAID SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER, A DISTANCE OF 77.96 FEET; THENCE NORTH 89°34'38" WEST, A DISTANCE OF 421.18 FEET; THENCE SOUTH 88°31'10" WEST, A DISTANCE OF 243.02 FEET TO A POINT ON THE WEST LINE OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 30; THENCE NORTH 0'41'24" WEST ALONG SAID WEST LINE, A DISTANCE OF 74.81 FEET TO THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 30; THENCE NORTH 89°27'17" EAST ALONG THE NORTH LINE OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 30, A DISTANCE OF 664.11 FEET TO THE POINT OF BEGINNING.

EXCEPTING THEREFROM ANY PORTION LYING WITHIN THE COUNTY ROAD RIGHT OF WAY.

TRACT III

A NON-EXCLUSIVE ROADWAY EASEMENT WITH THE SOUTHERLY LINE OF SAID ROADWAY BEING 20 FEET SOUTH OF THE SOUTH LINE OF THE ABOVE DESCRIBED TRACT II AND THE NORTHERLY LINE OF SAID ROADWAY BEING THE SOUTH LINE OF THE ABOVE DESCRIBED TRACT II.

SURVEYOR'S NARRATIVE:

THE PURPOSE OF THIS PROJECT IS TO ESTABLISH THE BOUNDARY OF THE SUBJECT PROPERTY AND LOCATE STRUCTURES AND POTENTIAL ENCROACHMENTS. THE BOUNDARY WAS ESTABLISHED BY HOLDING FOUND MONUMENTS OF RECORD AND PROPORTIONATE RECORD ANGLES AND DISTANCES.

THE NORTH LINE, ALONG THE UMATILLA RIVER, WAS ESTABLISHED BY LOCATING THE ORDINARY HIGH WATER MARK (OHWM). THE OHWM WAS LOCATED AT THE TOP OF A SHELF ALONG THE SOUTH EDGE OF THE UMATILLA RIVER. IT APPEARS THAT THE SOUTH EDGE OF THE UMATILLA RIVER HAS BEEN GRADUALLY MOVING FURTHER SOUTH BY LOOKING AT RECORD DISTANCES TO THE OHWM IN RELATION TO OUR CURRENT

THE SOUTH LINE (SOUTH LINE OF TRACT II, INSTRUMENT NO. 2020-7100045) WAS ESTABLISHED BY HOLDING THE MIDSECTION LINE OF SECTION 30, MEASURED BETWEEN THE EAST AND WEST QUARTER CORNERS. THE EAST LINE OF SAID TRACT II WAS ESTABLISHED BY HOLDING THE NORTHERLY PROJECTION OF THE EAST LINE OF "BELL PARCEL" AS SURVEYED IN EDWARDS' 2003 AND 2005 SURVEY'S (SEE R1 AND R2).

THE SOUTH LINE OF TRACT I, INSTRUMENT NO. 2020-7100045, WAS ESTABLISHED BY HOLDING THE BEARING OF THE HEREINABOVE MENTIONED MIDSECTION LINE, PROJECTED WESTERLY FROM EDWARDS' MONUMENT FOUND AT THE SOUTHEAST CORNER OF SAID

THE EAST LINE OF TRACT I AND TRACT III, INSTRUMENT NO. 7100045, WAS ESTABLISHED BY HOLDING THE SECTION LINE BETWEEN SAID EDWARDS MONUMENT AT THE SOUTHEAST CORNER OF SAID TRACT I AND THE NORTHEAST CORNER OF SECTION 30. THE NORTHEAST CORNER OF SECTION 30 WAS FOUND DESTROYED BY RECENT ROAD WORK. ITS POSITION WAS COMPUTED UTILIZING RECORD SURVEY RECORDED IN FILE 19-080-C (KING, R5) AND CORNER RESTORATION FORM R5-19-080-C (KING).


THE WEST LINE WAS HELD AS THE EAST RIGHT-OF-WAY MARGIN OF COTTONWOOD BEND ROAD PER "NORTHWEST LIVESTOCK ROAD AND COTTONWOOD BEND ROAD LEGALIZATION SURVEY", PERFORMED BY UMATILLA COUNTY PUBLIC WORKS (ROBERTS, 2017, SEE R6).

THERE APPEAR TO BE SEVERAL ERRORS IN EDWARDS' 1982 SURVEY FOR OVERTON (SEE R3). THESE ERRORS ARE PRIMARILY IN DISTANCE AND RESULT IN LINE LENGTHS BEING SIGNIFICANTLY LONGER THAN MEASURED. IN HIS SUBSEQUENT 2003 AND 2005 SURVEYS HE CORRECTS THESE DISTANCES MAKING NO NOTE OF THE PREVIOUS DISTANCES. IN COMPUTING THE BOUNDARY OF THAT PARCEL SURVEYED FOR OVERTON, WE HAVE ELECTED TO HOLD THE DISTANCES AROUND THE HOUSE AND PUT ALL OF THE ERROR IN THE LINES GOING WESTERLY TO THE ROAD RIGHT-OF-WAY. NOTE THAT THIS RIGHT-OF-WAY IS NOT THE SAME RIGHT-OF-WAY AS SURVEYED IN THE HEREINABOVE MENTIONED ROAD LEGALIZATION SURVEY. IN EDWARDS' THREE SURVEYS HE HOLDS THE THE 1/16 SECTION LINE AS THE CENTERLINE OF THE ROAD RIGHT-OF-WAY AND OFFSETS IT 20 FEET IN EACH DIRECTION. THE 2017 ROAD LEGALIZATION SURVEY HOLDS THEIR SURVEYED CENTERLINE AS IT FULLY ENCOMPASSES THE LOCATION OF THE EXISTING ROAD WITHOUT CREATING GAPS BETWEEN NEIGHBORING
