

This survey was performed at the request of Mr. Gustavo Morales. The purpose of the survey was to identify and monument the line between Lots 34 and 35 as shown hereon in preparation for building

Both owners, Morales and Nichols, told me that they had seen the original monument and knew of its location. However, neither of them had seen the monument since the installation of a new underground electric facility on the west side of the sidewalk the year before. In searching for the monuments along the east line of the addition. a significant disturbance of the area was notable. I did not find the monument at the northeast corner of Lot 35 so reestablished it

I first made measurements to all of the centerline monuments in this addition to determine if the original monuments were reasonably well set by a comparison with the original plat. Having concluded that they were, I calculated a point on the east line of the addition on the centerline of Eagle Avenue by holding record distance east from the Eagle / Blue Jay intersection. I then proportioned the east corner of the Lot 34/35 common line between the point first calculated above and the found monument at the NE corner of Lot 1.

This survey was performed with a Trimble R8S Base./Rover pair.
