

- SET 5X8"X30" IRON REBAR WITH 1 1/4" BLUE PLASTIC CAP MARKED "WELLS SURVEYING PLS 54657."
- FOUND REBAR WITH YELLOW CAP PER SURVEY NO. 03-47-B.
- FOUND BRASS DISK IN MONUMENT BOX BY ODOT PER SURVEY NO. 14-027-B. THE MONUMENTS PRIOR TO SAID SURVEY WERE DESTROYED BY STREET CONSTRUCTION AND REPLACED IN SAID SURVEY. BASED ON PREVIOUS TIES TO SURVEY MONUMENTS LOCATED IN THE ADJOINING BLOCKS AND STREETS WHICH WERE SET PRIOR TO THESE MONUMENTS BEING REPLACED AND ARE STILL IN EXISTANCE, THERE ARE ERRORS OF UP TO 0.05' +/- IN THE PRESENT MONUMENT LOCATIONS. I HELD ALL CURRENT MONUMENT POSITIONS FOR THIS SURVEY.


EZELL TRACT

NARRATIVE

THIS SURVEY WAS MADE AT THE REQUEST OF JACK EZELL TO SURVEY THE BOUNDARY OF THE PROPERTY DESCRIBED IN INSTRUMENT NO. 2024—06852. PORTIONS OF THE PROPERTY AND ADJOINING PROPERTY WERE SURVEYED IN PROPERTY LINE ADJUSTMENT SURVEY NO. 03—047—B. IN SAID SURVEY, A 3.00' STRIP OF PROPERTY WAS TAKEN FROM THE EZELL TRACT, AND ADDED TO THE LIBRARY TRACT. FOR SOME REASON ONLY THE 3.00' WIDE ADJUSTING TRACT DEED WAS RECORDED. THE ADJUSTED EZELL TRACT AND LIBRARY TRACT DEEDS WERE NOT. THEREFORE NEITHER CURRENT DEED MENTIONS THE 3.00' WIDE TRACT. THE INTENT OF THE PROPERTY LINE ADJUSTMENT SURVEY WAS TO REMOVE 3.00' FROM THE EZELL TRACT AND ADD IT TO THE LIBRARY TRACT. THEREFORE THE DEED DESCRIPTIONS SHOULD READ AS DESCRIBED IN THE REVISED DEED DESCRIPTIONS PARAGRAPH ABOVE.

THIS SURVEY WAS MADE WITH A ONE PERSON CREW USING A LEICA GS14 GPS RECEIVER OPERATED OVER THE OREGON REALTIME GNSS NETWORK. CONTROLLING AND SET MONUMENTS WERE VERIFIED BY MULTIPLE OBSERVATIONS.
