FOR PROPERTY LINE ADJUSTMENT IN A PORTION OF THE SE1/4 OF SECTION 31, AND A PORTION THE SW1/4 OF SECTION 32, TOWNSHIP 4 NORTH, RANGE 29 EAST, W.M., UMATILLA COUNTY, OREGON

SURVEY NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO DEPICT THE BOUNDARIES OF THE SUBJECT PROPERTIES FOR A PENDING SALE, THIS INITIAL SURVEY UNCOVERED THAT SEVERAL ISSUES EXIST WITH THE EXISTING LEGAL DESCRIPTIONS FOR TRACTS I-IV AS PROVIDED BY THE CLIENT AS WELL AS CONFLICTING SECTION BREAKDOWN AND MONUMENTATION FOR SECTION 31.

AN OVERLAP EXISTS IN THE BOUNDARY BETWEEN TRACT I AND TRACT III. THE DESCRIPTION FOR TRACT I DESCRIBES A PROPERTY BOUNDARY WHICH RUNS DOWN THE NORTH-SOUTH MID SECTION LINE OF THE SOUTHEAST QUARTER OF SECTION 31 AND EXTENDS INTO THE SOUTH HALF OF THE NORTHEAST QUARTER OF SAID SOUTHEAST QUARTER. NO BOUNDS CALL EXISTS IN THE DESCRIPTION FOR TRACT I TO INDICATE IF THE INTENT WAS TO BOUND ON THE ALIQUOT LINE. (ADDITIONAL RESEARCH WOULD BE NEEDED TO SEE WHICH PROPERTY HAS JUNIOR OR SENIOR RIGHTS TO THE GROUND). THIS JUNIOR-SENIOR RELATIONSHIP IS A NON-ISSUE AS THIS PROPERTY LINE ADJUSTMENT AND SUBSEQUENT DEEDS INTEND TO RECONFIGURE THESE TRACTS AND CLEAN UP THIS LEGAL DESCRIPTION.

AN OVERLAP EXISTS WITH A PORTION OF THE SOUTH HALF OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 31 WHICH LIES WITHIN THE BOUNDARY FOR THE PLAT OF THE TOWN OF FOSTER. THIS PORTION OF THE SECTION WAS NOT EXCEPTED OUT OF THE DEED BUT IS CONSIDERED MOOT AS THE TOWN OF FOSTER WAS PLATTED IN 1918. THE FENCE LINE PRESENT ALONG THE BOUNDARY OF THE TOWN OF FOSTER IS CONSISTENT WITH THE SHAPE AND SIZE OF THE PLAT. THE PLAT WAS COMPUTED FROM FOUND MONUMENTS OF RECORD ALONG THE NORTHEASTERLY EDGE OF SAID PLAT. THE PLAT OF THE TOWN OF FOSTER IS BEING FULLY EXCEPTED IN THE RESULTANT LEGAL DESCRIPTION OF PARCEL C AS SHOWN HEREON.

AERIAL IMAGERY RETRIEVED FROM UMATILLA COUNTY SURVEYOR'S OFFICE FROM 1980 WAS USED TO ESTABLISH THE HISTORIC LOCATION OF THE UMATILLA RIVER FROM 1980. THE APPROXIMATE CENTERLINE WAS APPROXIMATED FROM SAID IMAGERY AND IS USED FOR AREA COMPUTATIONS ONLY AND AS SUCH IS NOT DIMENSIONED.

THE LOCATION OF THE CENTERLINE OF THE UNION PACIFIC RAILROAD COMPANY'S MAIN TRACK WAS ESTABLISHED ON THE "AS-BUILT" RAIL CENTERLINE AND IS CONSISTENT WITH MONUMENTATION FOR NEIGHBORING PROPERTIES IN THE VICINITY.

A DISCREPANCY EXISTS BETWEEN THE BREAKDOWN OF SECTION 31 BETWEEN KRUMBEIN'S 1973 AND 1985 SURVEYS (I-21-C AND 85-143-B RESPECTIVELY) AND EDWARDS 1988 SURVEY (88-57-B). THIS SURVEY AGREES WITH THE REASONING AND POSITIONS ESTABLISHED BY EDWARDS BUT CONFLICTING EVIDENCE AND MONUMENTATION FROM THE TWO KRUMBEIN SURVEYS IS NOT THROWN OUT ALTOGETHER. THE BOUNDARIES OF TRACTS I, II, & III WERE ESTABLISHED HOLDING RECORD DISTANCES AND ANGLES FROM THE FOUND REMAINING MONUMENTATION PER THE KRUMBEIN SURVEYS WHICH IS CONSISTENT AND THE APPARENT ORIGINATION OF THE LEGAL DESCRIPTIONS DESCRIBED IN THE DEEDS FOR SAID TRACTS. AS SUCH, THOSE KRUMBEIN MONUMENTS FOUND WERE HELD TO CONTROL THOSE BOUNDARIES THEY ORIGINALLY REPRESENTED, REGARDLESS IN A DIFFERENCE IN SECTION BREAKDOWN. THIS SURVEY HOLDS THE MONUMENTS AND POSITIONS PER SURVEY 85-143-B TO CONTROL THE EXISTING BOUNDARIES OF TRACTS ! AND II AND USES THE MONUMENTS AND SECTION BREAKDOWN FROM EDWARDS 1988 SURVEY TO CONTROL THE SOUTHEAST QUARTER OF SECTION 31. THE OVERLAPS AND GAPS CREATED BY THESE CONFLICTING SURVEYS IS BEING ADDRESSED IN NEW LEGAL DESCRIPTIONS DESCRIBED HEREON MAINTAINING THE PREEXISTING BONAFIDE RIGHTS OF THE PROPERTIES MONUMENTED BY KRUMBEIN WITH THE CONTINUITY OF THE SUBSEQUENT EDWARDS SURVEY DETERMINATION. THIS IS SUPPORTED BY KRUMBEIN ACTING AS COUNTY SURVEYOR AND HIS DIRECTION TO KING IN SURVEY 23-042-C TO HOLD THE 1988 POSITION OF EDWARDS FOR THE S1/4 CORNER OF SECTION 31 OVER HIS POSITION FROM 1973.

THE NORTH, WEST, SOUTH, AND EAST LINES OF THE SOUTHEAST QUARTER OF SECTION 31 WERE ESTABLISHED BETWEEN FOUND MONUMENTS OF RECORD. THE NORTH-SOUTH CENTERLINE OF THE SOUTHEAST 1/4 OF SECTION 31 WAS COMPUTED BETWEEN THE FOUND MONUMENT OF RECORD AT THE CE 1/16TH CORNER SET BY EDWARDS AND THE COMPUTED EAST 1/16TH CORNER BETWEEN SECTIONS 31 AND 6 AT MIDPOINT ALONG THE SOUTH LINE OF THE SOUTHEAST 1/4 OF SECTION 31. 


