

DESCRIPTION

A PARCEL OF LAND SITUATED IN THE NORTHWEST QUARTER OF SECTION 14. TOWNSHIP 5 SOUTH, RANGE 31 EAST, WILLAMETTE MERIDIAN, TOWN OF UKIAH, UMATILLA COUNTY, STATE OF OREGON, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT THE CENTER OF SAID SECTION 14; THENCE RUNNING WEST 1300 FEET TO THE NORTHWEST CORNER OF BLOCK "M" OF FIRST ADDITION TO THE TOWN OF UKIAH; THENCE NORTH ON A PROLONGATION OF THE WEST LINE OF SAID BLOCK "M", A DISTANCE OF 60 FEET TO A POINT, WHICH IS THE POINT OF BEGINNING FOR THIS DESCRIPTION; THENCE NORTH 200 FEET TO THE SOUTHWEST CORNER OF BLOCK 20, OF SECOND ADDITION TO THE TOWN OF UKIAH; THENCE EAST 140 FEET TO THE SOUTHWEST CORNER LOT 2 IN BLOCK "K" OF THE ORIGINAL TOWN OF UKIAH; THENCE NORTH 120 FEET TO THE NORTHWEST CORNER OF SAID LOT 2, BLOCK "K"; THENCE EAST 80 FEET TO THE NORTHEAST CORNER OF SAID LOT 2, BLOCK "K"; THENCE SOUTH 120 FEET TO THE SOUTHEAST CORNER OF SAID LOT 2; BLOCK "K"; THENCE EAST 80 FEET TO THE SOUTHEAST CORNER OF SAID BLOCK "K"; THENCE NORTH 470 FEET TO THE NORTHEAST CORNER OF LOT 1, BLOCK "Q" of SAID ORIGINAL TOWN OF UKIAH; THENCE WEST 754 FEET ALONG THE NORTH LINES OF LOTS 1, 2, AND 3 OF SAID BLOCK "Q" AND ALONG THE NORTH LINE OF LOT 2, BLOCK 19, OF SECOND ADDITION TO THE TOWN OF UKIAH, AND ALONG A PROLONGATION OF SAID LINE TO A POINT IN BLOCK 29 OF SAID SECOND ADDITION; THENCE SOUTH 670 FEET TO A POINT ON THE SOUTH LINE OF BLOCK 22 OF SAID SECOND ADDITION: THENCE EAST 454 FEET TO THE POINT OF BEGINNING.


NOTES

-) THE REMONUMENTATION PLAT OF THE TOWN OF UKIAH SHOWS A 5/8" REBAR SET AT THE INTERSECTION OF THE CENTERLINES OF MAIN STREET AND LEAH STREET. NO MONUMENT WAS FOUND THERE BUT A 5/8" PIN WAS FOUND 30.00' EAST. THEREFORE A 5/8" REBAR WAS SET AT THE INTERSECTION POINT TO CONFORM WITH THE RECORDED PLAT.
- 2 ALL STREETS AND ALLEYS WITHIN THE SURVEYED AREA . ARE VACATED EXCEPT THAT PORTION OF WELL STREET AND LEAH STREET WHICH IS CROSS HATCHED.
- (3) SET THESE MONUMENTS APPROXIMATELY 4 INCHES BELOW SURFACE DUE TO FALLING IN TRAFFIC AREA. PLACED PROTECTIVE COVERING OVER BRASS CAP.


