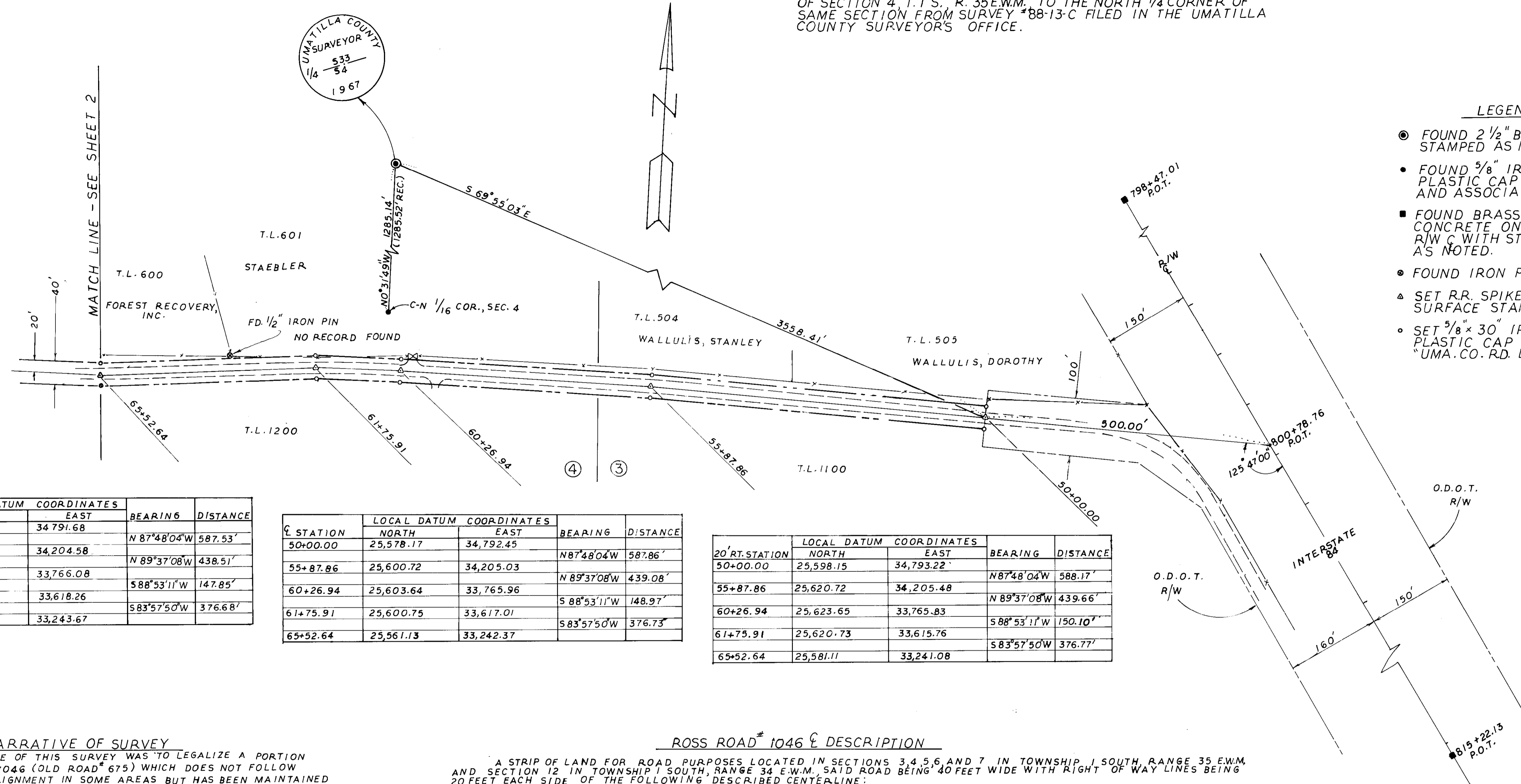

NARRATIVE OF SURVEY

THE PURPOSE OF THIS SURVEY WAS TO LEGALIZE A PORTION OF COUNTY ROAD #1046 (OLD ROAD #675) WHICH DOES NOT FOLLOW THE DEDICATED ALIGNMENT IN SOME AREAS BUT HAS BEEN MAINTAINED AND TRAVELLED AS IT NOW EXISTS FOR MANY YEARS. THIS LEGALIZATION SURVEY WAS INITIATED BY A PETITION TO VACATE A DEDICATED BUT NON-MAINTAINED SECTION OF ROAD #1046. THE INITIAL POINT, STATION 50+00.00, IS A POINT THAT WAS SET 500.00' FROM INTERSTATE 84 RIGHT-OF-WAY CENTERLINE STATION 800+78.76 AS PER HIGHWAY RIGHT-OF-WAY MAPS. THIS STATION WAS ESTABLISHED USING TWO BRASS CAP MONUMENTS FOUND SET IN CONCRETE IN THE MEDIAN. NORTH AND SOUTH ALIGNMENT OF STATION 50+00.00 WAS DETERMINED USING A SPLIT OF ROAD #1046 AS IT NOW EXISTS BECAUSE NO BEARING FROM I-84 TO STATION 50+00.00 COULD BE OBTAINED FROM HIGHWAY RIGHT OF WAY MAPS. THE ROAD WAS SURVEYED THROUGH A SERIES OF ANGLE POINTS. RAILROAD SPIKES WITH PUNCH MARKS SET BELOW THE ROAD SURFACE WERE USED ON CENTERLINE BECAUSE OF THE ROCKY NATURE OF THE SUBBASE OF THE ROAD. COORDINATES WERE ASSIGNED TO ALL POINTS USING ASSUMED COORDINATES ON STATION 230+07.48, THE END OF THE LEGALIZATION, AS NORTH 20,000.00 AND EAST 20,000.00. MONUMENTS WERE SET ON THE RIGHT-OF-WAY LINES WHEREVER POSSIBLE. WHERE THEY COULDN'T BE SET, THE COORDINATES SATISFY THE REQUIREMENTS OF ORS 209.150(3). INSTRUMENTS USED WERE A WILD T-16 ONE MINUTE THEODOLITE AND A WILD DI-5 E.D.M. BEARING BASE IS AS SHOWN ABOVE.

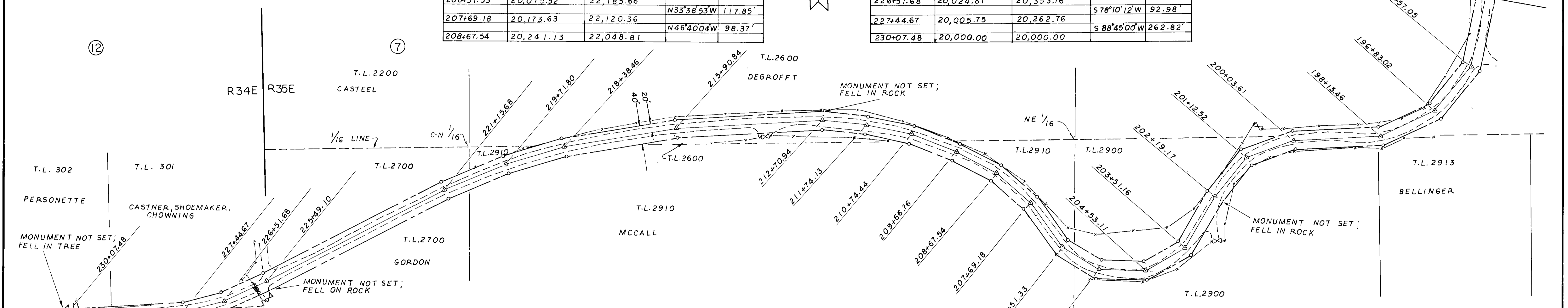
