

## NARRATIVE

1) THIS BOUNDARY LINE ADJUSTMENT WAS PERFORMED AT THE REQUEST OF TOM AND RAY WILLIAMS TO RECONFIGUE TAX LOTS 1800, 2701, AND 2702. THESE LANDS ARE A PORTION OF THOSE LANDS DESCRIBED IN INSTURMENTS FILED UNDER NO'S. R200 PG. 1699 AND R 305 PG. 0165.

2) DUE TO LACK OF SURVEY MONUMENTATION IN THIS AREA, SOME FENCE CORNERS HAVE BEEN ADOPED AS A PERPETUATION OF SECTION CORNER POSITIONS AS HAS BEEN DONE PREVIOUSLY (SEE SURVEY BY BARTELSON 98—108—B. THOSE CORNERS DETERMINED TO BE LOST WERE REESTABLISHED USING DOUBLE PROPORTIONATE MEASURE AS HAS BEEN DONE IN THE PAST (SEE SURVEY BY KRUMBEIN 82—46—B). SEE SHEET 1 FOR NOTES SPECIFIC TO EACH CORNER.

3) THIS SURVEY WAS PERFORMED USING TRIMBLE 4400 RECIEVERS BY EMPLOYING REAL TIME KINEMATIC TECHNIQUES HAVING STANDARD ERRORS OF 1CM = 2PPM TIMES THE MEASURED BASELINE LENGTH.

4) ALL MONUMENTS SHOWN WERE VISITED IN DECEMBER OF 1999.
