MUCH OF THE AREA HAS BEEN EXTENSIVELY FARMED IN THE PAST 20 YEARS AND EVIDENCE OF ORIGINAL GLO CORNER MONUMENTS DOES NOT EXIST. SECTION CORNERS NECESSARY FOR THIS SURVEY WERE RECOVERED OR REESTABLISHED BASED ON EARLIER RECORD SURVEYS.
