THIS SURVEY WAS MADE AT THE REQUEST OF MILLS MINT FARM, INC. TO ADJUST THE BOUNDARY OF TAX LOTS 4100 AND 4600 AS SHOWN. CONTROLLING MONUMENTS USED FOR SECTION 26 SUBDIVISION ARE SHOWN ON THE CONTROL DIAGRAM.. REVISED TAX LOT 4100 WAS SURVEYED AS SHOWN. REVISED TAX LOT 4600 IS UNSURVEYED.

THE NORTH LINE OF REVISED TAX LOT 4100 WAS LOCATED ON THE SOUTH RIGHT-OF-WAY LINE OF COUNTY ROAD NO. 1175, 30.00 FEET SOUTH OF THE NORTH LINE OF THE SE1/4 OF THE NW1/4 OF SECTION 26. THE WEST LINE OF REVISED TAX LOT 4100 WAS LOCATED ON THE NORTH-SOUTH CENTERLINE OF THE NORTHWEST QUARTER OF SECTION 26. THE SOUTH AND EAST LINES OF REVISED TAX LOT 4100 ARE ARBITRARY LINES ESTABLISHED TO MAKE REVISED TAX LOT 4100 4.01 ACRES IN SIZE.

WRITTEN DESCRIPTIONS FOR THE PROPERTY TO BE EXCHANGED BY BOUNDARY LINE ADJUSTMENT DEEDS ARE PREPARED SEPARATELY.

THE SURVEY WAS MADE WITH A TWO PERSON CREW USING TRIMBLE 5700 SERIES GEODETIC GPS RECIEVERS OPERATED IN REAL TIME KINEMATIC MODE. TIES TO CONTROL CORNERS AND TO MONUMENTS SET WERE VERIFIED BY REDUNDANT OBSERVATIONS. IN AREAS WHERE GPS SIGNAL WAS OBSCURED BY VEGETATION, A LEICA TCR 803, 3 SECOND TOTAL STATION WAS USED FOR CONTROL TIES AND MONUMENT SETS.


