
THIS SURVEY WAS PERFORMED AT THE REQUEST OF MR. CASEY MCLELLAN TO ADJUST EXISTING PARCELS WITHIN SECTIONS 32 AND 33 OF TWP. 6 NORTH, RGE. 35 EAST, W.M., AS DESCRIBED AS TRACTS ONE THROUGH FIVE AS DESCRIBED IN THAT SPECIAL WARRANTY DEED RECORDED AT FILE NO. 2016—6520216, UMATILLA COUNTY DEED RECORDS.

AS SHOWN HEREIN, TRACT 4 OF THE LAND DESCRIBED IS NOT BEING ADJUSTED AND IS THUS SHOWN FOR REFERENCE ONLY. TRACT 3 IS REFERRED TO AS AN EASEMENT; THEREFORE, THE PARCELS INVOLVED IN THIS BOUNDARY ADJUSTMENT ARE TRACTS 1, 2, AND 5, AS DESCRIBED IN SAID DEED.

THE LAND IN THIS SURVEY IS SERVED BY FIVE WELLS INTERCONNECTED WITH A SERIES OF WATER LINES, AND PUMP STATIONS, ALL OF WHICH WORK TOGETHER TO PROVIDE IRRIGATION WATER TO THE THREE PARCELS. THE PIPE NETWORK IS REPRESENTED HEREIN AS A HEAVY DASHED LINE LABELED AS "CENTERLINE OF 10' IRRIGATION EASEMENT." THE OWNERSHIPS OF THE THREE PARCELS SHALL WORK TOGETHER TO RECORD AN EASEMENT THAT WILL BE MUTUALLY BENEFICIAL, AND SHALL DESCRIBE THE GEOGRAPHIC LOCATION OF PIPE NETWORK, INCLUSIVE OF WELLS AND PUMP STATIONS.

AS SHOWN HEREIN, UNLESS INDICATED OTHERWISE, I HAVE HELD THE LOCATIONS OF PROPERTY CORNERS SHOWN ON HULT'S 2017 SURVEY AS CONTROLLING THE BOUNDARY OF THE PARCELS OF THIS SURVEY. WHERE I AM IN DISAGREEMENT WITH MR. HULT'S PINS, I HAVE PROVIDED THE RELATIONSHIPS FROM THE CORNERS TO THE PINS.

THIS SURVEY WAS PERFORMED AS A REAL TIME KINEMATIC SURVEY USING DUAL FREQUENCY GPS RECEIVERS WITH A PRECISION OF ONE CENTIMETER ± 1 PPM. TOPOGRAPHIC FEATURES SHOWN HEREIN WERE LOCATED USING CONTROLLED ORTHO—PHOTOGRAPHY BY OUR IN HOUSE UNMANNED AERIAL SYSTEMS. MONUMENTS WERE ALL VISITED IN JULY OF 2017.
