NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO STAKE THE EASTERLY RIGHT-OF-WAY MARGIN OF COUNTY ROAD NO. 637, HODGSON ROAD IN PREPARATION FOR A FUTURE ROAD IMPROVEMENT PROJECT. THE AREA OF INTEREST WAS THE UNDEVELOPED PORTION OF THE ROAD LOCATED BETWEEN THE QUARTER CORNER COMMON TO SECTIONS 22 & 23 AND THE END OF EXISTING IMPROVEMENTS (STATION 28+72.44 TO STATION 46+00). HODGSON ROAD WAS LEGALIZED IN 2006 AND DOCUMENTED IN UMATILLA COUNTY BOARD OF COMMISSIONERS ORDER RD2006-18 (R1) AND SURVEY 06-473-C (R2). IN RETRACING THE 2006 LEGALIZATION OF HODGSON ROAD I FOUND THE QUARTER CORNER COMMON TO SECTINOS 22 & 23 TO BE OUT OF POSITION. I TIED SECTION CORNERS NORTH AND SOUTH AND REPLACED IN PROPORTIONATE LOCATION ACCORDING TO DISTANCES REPORTED IN THE LEGALIZATION SURVEY. ALL REFERENCE MONUMENTS WERE FOUND AND CHECKED WELL WITH THE REESTABLISHED LOCATION.

ALL RECORD DISTANCE REFERENCES REPORTED HEREON FROM SURVEY 06-473-C (R2) HAVE BEEN CONVERTED TO GROUND DISTANCES PER THE SCALE FACTOR PROVIDED ON SHEET 4 OF SAID SURVEY.

SURVEY DATA WAS COLLECTED USING LEICA GS15 GNSS RECEIVERS USING A COMBINATION OF STATIC AND RTK METHODS. BEARINGS ARE GRID, DISTANCES ARE GROUND - INTERNATIONAL FEET.




RIGHT-OF-WAY CENTERLINE

RIGHT-OF-WAY LINE




