

NARRATIVE

THIS SURVEY HAS BEEN PREPARED AT THE REQUEST OF KENT MADISON OF K&L MADISON, LLC. THE PURPOSE IS TO MARK THE BOUNDARIES OF THAT PROPERTY DESCRIBED UNDER INSTRUMENT NUMBER 2021-7310203, OFFICE OF COUNTY RECORDS, UMATILLA COUNTY, OREGON. THE BOUNDARIES AS MAPPED HEREON HAVE BEEN SURVEYED ACCORDING TO THE AFOREMENTIONED VESTING DEED TOGETHER WITH INFORMATION PROVIDED IN PIONEER TITLE COMPANY PRELIMINARY REPORT FOR TITLE INSURANCE DATED AUGUST 18, 2021, ORDER NO. 103329.

CONTROLLING SECTION CORNERS AS REPORTED ON SURVEYS 98-155-C(R1), AND CORNER RESTORATION FORM 3N29G13(R3) WERE USED IN CONJUNCTION WITH SECTION SUBDIVISION PROVIDED ON SURVEY 98-176-C(R2) TO SUBDIVIDE SECTION 9 AS SHOWN.

INTERSTATE 84 RIGHT-OF-WAY IS CONTROLLED BY THE FOUND BRASS DISK MONUMENTS MARKING THE 65-FOOT SOUTHERLY OFFSET TO THE WESTBOUND CENTERLINE AS DEPICTED ON RIGHT OF WAY MAP 8B-34-18(R4).

HIGHWAY 320 (A.K.A. OLD HIGHWAY 30, COUNTY ROAD NO. 1300, THIELSON STREET), NOTED HERON AS THE THE 'A' LINE CENTERLINE, IS CONTROLLED BY MONUMENTS ESTABLISHED BY SAID MAP 8B-34-18 AND MONUMENTS ESTABLISHED BY SURVEY 98-176-C(R2) AND THE PLAT FOR ECHO HEIGHTS SUBDIVISION(R5). MONUMENTS FOUND AT 'A' 25+46.70, 'A' 26+00, 'A' 27+00, AND 'A' 27+70 AS SHOWN WERE USED TO ESTABLISH THE 'A' LINE TANGENT PER MAP 8B-34-18 AND CIRCUIT COURT CASE 9399. THIS TANGENT WAS PROJECTED SOUTHEASTERLY TO INTERSECT THE P.C. OF COUNTY ROAD NO. 1300 (A.K.A OLD HIGHWAY 30) AS ESTABLISHED BY SURVEY 98-176-C. THE RESULTING DATA FITS WELL BUT DOES RESULT IN A SLIGHT NON-TANGENT CURVE AS A RESULT OF HOLDING THE MONUMENTATION. BRASS DISK CENTERLINE MONUMENTS (POINTS 225 & 226) WERE FOUND NEAR THE 'A'LINE CENTERLINE AS ESTABLISHED IN THIS SURVEY BUT HAVE NOT BEEN HELD FOR RIGHT-OF-WAY DETERMINATION. THESE MARKERS REPRESENT A CONSTRUCTION CENTERLINE AS ESTABLISHED BY SURVEY 91-039-C AND DO NOT COINCIDE WITH THE AFOREMENTIONED MONUMENTATION WHICH CONTROLS THE 'A' LINE AS MONUMENTED IN 8B-34-18 AND DESCRIBED IN CIRCUIT COURT CASE 9399.

SURVEY 02-137-B(R7) DESCRIBES RESOLVING COUNTY ROAD NO. 1300 RIGHT OF WAY FOR USE IN A FUTURE LEGALIZATION PROCESS. UNFORTUNATELY, THE LEGALIZATION PROCESS WAS NEVER COMPLETED BY THE COUNTY; THEREFORE, THE RESOLUTION PER SURVEY 02-137-B COULD NOT BE UTILIZED IN THIS SURVEY.

ODOT MAP 10B-16-32(R8) DEFINES A CENTERLINE FOR COUNTY ROAD NO. 1300 FOR USE IN PERMANENT SLOPE EASEMENT ACQUISITION. SEE INSTRUMENT NUMBER 2002-4190119, RECORDS OF UMATILLA COUNTY, OR. THIS CENTERLINE WAS MONUMENTED IN SURVEY 14-128-B(R9). ALL OF THE MARKERS WERE FOUND IN GOOD CONDITION AND HELD IN CENTERLINE DETERMINATION. THIS CENTERLINE VARIES SLIGHTLY FROM THE RIGHT OF WAY CENTERLINE AS MONUMENTED IN THIS SURVEY, AS FURTHER INDICATED IN THE LEGEND. THIS MONUMENTATION AND RESULTING CENTERLINE WAS USED FOR RESOLUTION OF THE SLOPE EASEMENTS ONLY. SURVEY R8 AND R9 WERE COMPLETED IN METERS. REFERENCES TO THOSE SURVEYS AS SHOWN HEREON ARE ALSO IN METERS, AS INDICATED BY USE OF THE ASTERISK (*) IN THE RECORDING REFERENCE. 1 INTERNATIONAL FOOT = .3048 METERS. ALL OTHER REFERENCES ARE IN INTERNATIONAL FEET AND COINCIDE WITH THE UNITS OF THIS SURVEY AS NOTED BELOW.


