
## RECORD OF SURVEY

LYING IN A PORTION OF THE WEST-HALF OF THE SOUTHWEST QUARTER OF SECTION 4, TOWNSHIP 2 NORTH, RANGE 32 EAST, W.M., CITY OF PENDLETON, UMATILLA COUNTY, OREGON



THIS SURVEY WAS PREPARED AT THE REQUEST OF CRH AMERICAS MATERIALS IN MAY 2025. THE PURPOSE OF THIS SURVEY WAS TO PREPARE A RECORD OF SURVEY AND SET PROPERTY CORNER MONUMENTS FOR THE THREE INTERSTATE CONCRETE & ASPHALT COMPANIES TAX LOTS 800, 900 AND 1000 AS DESCRIBED IN THAT CERTAIN WARRANTY DEED RECORDED UNDER INSTRUMENT NO. 2023-07098, RECORDS OF UMATILLA COUNTY, OREGON BEING LOCATED IN THE SOUTHWEST QUARTER OF SECTION 4, TOWNSHIP 2 NORTH, RANGE 32 EAST OF THE WILLAMETTE MERIDIAN, PENDLETON, UMATILLA COUNTY, OREGON.

PRELIMINARY FIELD WORK WAS PREFORMED ON MAY 30, 2025, BY CAMERON GREEN, EQUIPMENT USED IN CONJUNCTION WITH THIS SURVEY WERE TRIMBLE R12i DUAL FREQUENCY MULTI-CONSTELLATION GNNS RECEIVERS OPERATED IN STATIC MODE & RTK WITH LOGGING. DATA COLLECTION WAS ACCOMPLISHED UTILIZING A TRIMBLE TSC7 ELECTRONIC DATA COLLECTOR. STATIC DATA WAS POST PROCESSED THROUGH THE NATIONAL GEODETIC SURVEY (NGS) ONLINE USERS POSITIONING SYSTEM (OPUS). RTK & LOGGING DATA WAS PROCESSED USING TRIMBLE BUSINESS CENTER (TBC) VERSON 2024-10. PROPERTY CORNER MONUMENTS WERE SET ON JUNE 4, 2025, BY CAMERON GREEN AND CLAYTON PICKETT USING AFOREMENTIONED EQUIPMENT.

WE BEGAN THE SURVEY BY LOCATING AND MAKING OBSERVATIONAL TIES TO EXISTING SECTION 4 MONUMENTS, LOCAL PROPERTY CORNER MONUMENTS AND TO ROAD CENTERLINE MONUMENTS. ALL MONUMENTS SHOWN AS FOUND AND ACCEPTED ON THIS SURVEY WERE LOCATED WITHIN AN ACCEPTABLE AND REASONABLE TOLERANCE OF RECORD POSITION, 0.10' +/-.

THE EXTERIOR BOUNDARIES OF THE PARCELS SHOWN HEREON WERE DETERMINED AS FOLLOWS: THE EXTERIOR WEST BOUNDARY OF THIS SURVEY WAS DETERMINED BY HOLDING A LINE BETWEEN FOUND MONUMENTS AT THE SOUTHWEST CORNER AND THE WEST-QUARTER CORNER OF SAID SECTION 4. THE EXTERIOR NORTH BOUNDARY OF THIS SURVEY IS THE NORTH LINE OF THE SOUTH 330-FEET OF THE SOUTHWEST QUARTER OF SAID SECTION 4. THE SOUTH LINE OF SAID SECTION 4 WAS DETERMINED BY HOLDING A LINE BETWEEN FOUND MONUMENTS AT THE SOUTHWEST CORNER AND THE SOUTHEAST CORNER OF SAID SECTION 4. THE SOUTH-QUARTER CORNER OF SAID SECTION 4 WAS COMPUTED AT THE SINGLE PROPORTION LOCATION ALONG SAID SOUTH LINE. THE SOUTH LINE OF THE SOUTHWEST QUARTER WAS THEN

THE EXTERIOR EAST BOUNDARY OF THIS SURVEY IS A LINE 437.07 FEET EAST OF THE WEST LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 4 WHEN MEASURED AT RIGHT ANGLES. HISTORICAL DEEDS AND PREVIOUSLY RECORDED SURVEYS DESCRIBE AND DEPICT THIS LINE AS BEING 436.2 FEET EAST OF THE WEST LINE OF SAID SOUTHWEST QUARTER. I CHOOSE TO HOLD THE FOUND 5/8-INCH IRON REBAR SHOWN HEREON AS THE BEST EVIDENCE OF THE TRUE LOCATION OF THIS LINE AND AS SHOWN IN SURVEY REFERENCE NO. 1, A SURVEY BY H.L. MELTON IN DECEMBER 1951. ANOTHER FOUND 5/8-INCH IRON REBAR FOUND 34.00 FEET WEST OF THE PREVIOUSLY MENTIONED IRON REBAR CHECKS VERY WELL WITH THE DIMENSION SHOWN ON SAID SURVEY.

THE EXTERIOR SOUTH BOUNDARY OF THIS SURVEY IS THE NORTH RIGHT-OF-WAY LINE OF WESTGATE STREET (AKA OLD OREGON TRAIL HIGHWAY & US HIGHWAY 30). THE CENTERLINE OF SAID WESTGATE WAS DETERMINED BY HOLDING A LINE BETWEEN FOUND ROAD CENTERLINE MONUMENTS AS SHOWN HEREON. THE ROAD CENTERLINE WAS THEN OFFSET 40.00 FEET AND 50.00 FEET NORTHERLY ACCORDING TO OREGON STATE HIGHWAY DEPARTMENT RIGHT-OF-WAY PLANS 4B-23-20, EAST UNIT STANFIELD - PENDLETON SECTION, OLD OREGON TRAIL - UMATILLA COUNTY, DATED 02-1935, REVISED 03-1956 & 08-1963.

THE INTERIOR BOUNDARIES OF THE PARCELS SHOWN HEREON WERE DETERMINED BY DEED DIMENSIONS. THE INTERIOR LINE BETWEEN TRACT 2 AND TRACT 3 WAS CREATED BY A DISTANCE-DISTANCE INTERSECTION BY HOLDING THE DEED DISTANCE OF 171.3' ALONG THE NORTH LINE AND BY HOLDING THE DEED DISTANCE OF 139.92 ALONG THE SOUTH LINE.

BEGINNING AT A POINT 66 FEET NORTH FROM AND 436.20 FEET EAST FROM THE SOUTHWEST CORNER OF SECTION 4, TOWNSHIP 2 NORTH, RANGE 32, EAST OF THE WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON, SAID POINT ALSO BEING ON THE NORTH LINE OF THE WM. C. MCKAY DONATION LAND CLAIM; THENCE WESTERLY ALONG THE WM. C. MCKAY DONATION LAND, A DISTANCE OF 34 FEET; THENCE NORTH 80°19' WEST, A DISTANCE OF 139.92 FEET; THENCE NORTHERLY, A DISTANCE OF 240.82 FEET; THENCE EASTERLY ON A LINE PARALLEL WITH AND 264 FEET NORTHERLY FORM THE NORTH LINE OF SAID WM. C. MCKAY DONATION LAND, A DISTANCE OF 171.30 FEET TO THE WEST LINE OF THAT TRACT OF LAND CONVEYED TO GORDON L. WESTWOOD, ETUX, BY DEED RECORDED IN BOOK 205, PAGE 415, DEED RECORDS; THENCE SOUTHERLY ALONG THE WEST LINE OF SAID WESTWOOD TRACT, A DISTANCE OF 264 FEET TO THE POINT OF BEGINNING; EXCEPTING THEREFROM ANY PORTION LYING WITHIN THE HIGHWAY RIGHT-OF-WAY.


