

Previous Renewals / Surveys, etc.

Corner originally set by Daniel Chaplin under contract No. 107 dated September 21, 1864. His record reads: Set stone 18x10x8 for corner to secs. 23, 24, 25, and 26. Zenas Moody set a new corner under contract No. 164 dated October 4, 1871. His record reads: Set stone 20x18x14 for corner to sections 25, 26, 23 and 24. Currin and Noland, under special instructions dated May 4th, 1887 re-established the corner. Their record reads: To old corner. Reestablished corner. Set stone, 16x10x8 ins., 12 ins. in the ground for 1/4 sec. cor. marked 1/4 on W. face. Dug pits, 18 x 18 x 12 ins., N. and S. from stone, 5 1/2 ft. dist. and raised a mound of earth 1 1/2 ft. high, 3 1/2 ft. base alongside. In survey 02-161-B I set a 1"x24" iron rebar with a 2" aluminum cap stamped as shown in the diagram below. In survey 04-182-B, Dave Krumbein reports finding a bent iron rebar at this corner.

Monument and Accessories found: (condition and source)
I found the aluminum cap and rebar from my survey 02-161-B in good condition. The reported iron rebar from survey 04-182-B is at a corner another mile to the north.
