

Previous Renewals / Surveys, etc.

Corner originally set by Daniel Chaplin under contract No. 107, dated September 21, 1864. His record reads: Set post for 1/4 section corner in mound of earth with charred stake, pits, etc., as per instructions. J. Kimbrell in record of survey in Book 1, Page 488, states: Set stone 16 x 8 x 7, dated February 12, 1903.

Monument and Accessories found: (condition and source) None. The point falls in the center of the old highway.



MONUMENT (S) AND ACCESSORIES SET (Procedures and Description)
At the intersection of the center section line fence of Section 27 and the centerline of the old highway, I set a 1 1/2" x 30" galvanized iron pipe with a 2 1/2" brass cap flush with the surface of the asphalt in an 8" concrete plug. The cap is stamped as shown in the diagram above.

For references I set four 5/8" by 24" iron rebars with 1 1/4" orange plastic caps stamped WTS and 56295LS as described below:

an iron rebar bears N09°06'31"W, 163.24 feet on the south side of a power pole; an iron rebar bears N15°07'53"E, 149.29 feet, 2 feet below the surface of a plowed field; an iron rebar bears S22°21'22"E, 119.00 feet, 2 feet below the surface of a plowed field; an iron rebar bears S13°10'20"W, 107.63 feet on the south side of a power pole;

The monument was set references tied using a Trimble R7/R8 RTK GPS system.
