A 15" white fir bears N 27° W-25.2 feet, scribed: 1/4835 SC BT. A 26" white fir bears N 13° W-28.5 feet, scribed: 1/4835 SC BT. A 13" white fir bears N 0 1/2° W-16.3 feet, scribed: 1/4835 SC BT. A 5/8" x 30" iron pin with yellow plastic cap stamped "OR PLS 1106" bears N 85° E-15.3 feet.
