MONUMENT SET: At center of found stone mound, set a 2 1/2" brass cap on a 1 1/4" x 30" galvanized iron pipe, 16" in the ground, with mound of stone to cap (marked as shown in the monument detail).

Set steel fence post 3.0 feet North of monument, with witness sign attached.

A $5/8" \times 30"$ iron pin with yellow plastic cap stamped "OR PLS 1106-WA PLS 17372" bears N 80° W-9.8 feet.

A 20" douglas fir bears N 01° W-44.0 feet, scribed: T1N R34E S35 SC RT.

A 15" douglas fir bears N 24° E-63.5 feet, scribed: TlN R34E S36 SC BT.

A $5/8" \times 30"$ iron pin with yellow plastic cap stamped "OR PLS 1106-WA PLS 17372" bears N 60° E-22.3 feet.

Attached bearing object signs to each iron pin. Set a steel fence post near each iron pin with witness sign attached. Bearing trees have a brass washer stamped 'PLS 1106' nailed to the face of the blaze. Atached bearing object and witness signs to each tree; painted a 6" band and face of blaze red.
